## Decidability of Reachability for Right-shallow Context-sensitive Term Rewriting Systems

The reachability problem for an initial term, a goal term, and a rewrite system is to decide whether the initial term is reachable to goal one by the rewrite system or not. The innermost reachability problem is to decide whether the initial term is reachable to goal one by innermost reductions of the rewrite system or not. A context-sensitive term rewriting system (CS-TRS) is a pair of a term rewriting system and a mapping that specifies arguments of function symbols and determines rewritable positions of terms. In this paper, we show that both reachability for right-linear right-shallow CS-TRSs and innermost reachability for shallow CS-TRSs are decidable. We prove these claims by presenting algorithms to construct a tree automaton accepting the set of terms reachable from a given term by (innermost) reductions of a given CS-TRS.

## 1. Introduction

The reachability problem for two given terms $s, t$, and a reduction of a rewrite system $R$ is to decide whether $s$ is reachable to $t$ by the reduction of $R$ or not. Decision procedures of the problem for ordinary reductions of term rewriting systems (TRSs) are applicable to security protocol verification ${ }^{7}$ ) and to solving other problems of TRSs. Since it is known that this problem is undecidable for general TRSs, efforts have been made to find subclasses of TRSs in which the reachability is decidable or undecidable ${ }^{1), 4,5), 9), 13)-18)}$, as shown in Fig. 1.
A context-sensitive TRS ${ }^{12)}$ (CS-TRS) is a pair of TRSs and a mapping from a function symbol to a set of natural numbers, where the mapping is used to specify that arguments are rewritable or not. CS-TRS is used in evaluating if

... then ... else ... or case structures.
We have already shown that reachability is decidable for linear right-shallow CS-TRSs ${ }^{10}$. However, linear right-shallow is not a large enough class to express practical programs (e.g., multiplication).

In this paper, we show that reachability is decidable for right-linear rightshallow CS-TRSs. Right-linear right-shallow, however, is still not enough to express practical programs precisely, but we can express programs closer to the precise one.

Innermost reduction is a strategy that rewrites innermost redexes, and is known as good at representing call-by-value computation widely used in most programming languages. Therefore, the languages that adopt call-by-value computation and if ... then ... else ... structures (e.g., C languages) have computation models defined by the innermost reduction of CS-TRSs. For innermost reduction of TRSs and CS-TRSs, some decidable classes of reachability are known ${ }^{6), 8), 10), 11)}$. However, these classes do not have a large enoughe similarly to the case of the ordinary reduction of CS-TRSs.

In this paper, we also show that reachability for innermost reduction (innermost reachability) is decidable for shallow CS-TRSs.
We show the results of this paper by presenting two algorithms. The first algorithm constructs a tree automaton (TA) recognizing the set of terms reachable from a given term and a given right-linear right-shallow CS-TRS. This algorithm is based on the procedure for linear right-shallow CS-TRSs ${ }^{10)}$, and we introduce the idea in Refs. 14) and 17) to adopt the procedure to left-non-linear CS-TRSs as well. The second algorithm constructs a tree automaton with constraints between brothers (TACBB) that recognize the set of terms innermost reachable from a given term and a shallow CS-TRS. The second algorithm is achieved by introducing the TACBB $\mathcal{A}_{\mathrm{NF}}$ that accepts the set of normal forms to check whether each subterm is rewritable or unrewritable

## 2. Preliminary

We use the usual notations of rewrite systems ${ }^{2)}$ and tree automata ${ }^{3)}$. Let $F$ be a set of function symbols with fixed arity and $X$ be an enumerable set of variables. The arity of function symbol $f$ is denoted by $\operatorname{ar}(f)$. Function symbols with $\operatorname{ar}(f)=0$ are constants. The set of terms, defined in the usual way, is denoted by $\mathcal{T}(F, X)$. A term is linear if no variable occurs more than once in the term. The set of variables occurring in $t$ is denoted by $\operatorname{Var}(t)$. A term $t$ is ground if $\operatorname{Var}(t)=\emptyset$. The set of ground terms is denoted by $\mathcal{T}(F)$.
A position in a term $t$ is defined, as usual, as a sequence of positive integers, and the set of all positions in a term $t$ is denoted by $\operatorname{Pos}(t)$, where the empty sequence $\varepsilon$ is used to denote root position. The depth of a position $p$ is defined as the length of $p$ and denoted as $|p|$. The height $|t|$ of a term $t$ is defined as $\max (\{|p| \mid p \in \operatorname{Pos}(t)\})$. A term $t$ is shallow if the depths of variable occurrences in $t$ are all 0 or 1 . The subterm of $t$ at position $p$ is denoted by $\left.t\right|_{p}$, and $t\left[t^{\prime}\right]_{p}$ represents the term obtained from $t$ by replacing the subterm $\left.t\right|_{p}$ by $t^{\prime}$. If a term $s$ is a subterm of $t$ and $s \neq t, s$ is a proper subterm of t . We denote $s \unlhd t$ $(s \triangleleft t)$ such that a term $s$ is a (proper) subterm of $t$. A context $C$ is a term that contains the symbol $\square$, and $C[t]_{p}$ represents the term obtained by replacing $\square$ in the position $p$ of $C$ by $t$.
A substitution $\sigma$ is a mapping from $X$ to $\mathcal{T}(F, X)$ whose domain $\operatorname{Dom}(\sigma)=$
$\{x \in X \mid x \neq \sigma(x)\}$ is finite. The term obtained by applying a substitution $\sigma$ to a term $t$ is written as $t \sigma$. The term $t \sigma$ is an instance of $t$.

A rewrite rule is an ordered pair of terms in $\mathcal{T}(F, X)$, written as $l \rightarrow r$, such that $l \notin X$ and $\operatorname{Var}(l) \supseteq \operatorname{Var}(r)$. We say that variables in $\operatorname{Var}(l) \backslash \operatorname{Var}(r)$ are erasing. A term rewriting system (over $F$ ) (TRS) is a finite set of rewrite rules. Rewrite relation $\underset{R}{\longrightarrow}$ induced by a TRS $R$ is as follows: $s \underset{R}{\vec{~}} t$ if and only if $s=s[l \sigma]_{p}$, and $t=s[r \sigma]_{p}$ for some rule $l \rightarrow r \in R$, with substitution $\sigma$ and position $p \in \operatorname{Pos}(s)$. We call $l \sigma$ a redex. We sometimes write $\vec{R}^{p}$ by presenting the position $p$ explicitly.

A rewrite rule $l \rightarrow r$ is left-linear (resp. right-linear, linear, right-shallow, shallow) if $l$ is linear (resp. $r$ is linear, $l$ and $r$ are linear, $r$ is shallow, $l$ and $r$ are shallow). A TRS $R$ is left-linear (resp. right-linear, linear, right-shallow, shallow) if every rule in $R$ is left-linear (resp. right-linear, linear, right-shallow, shallow).

Let $\rightarrow$ be a binary relation on a set $\mathcal{T}(F)$. We say $s \in \mathcal{T}(F)$ is a normal form (with respect to $\rightarrow$ ) if there exists no term $t \in \mathcal{T}(F)$ such that $s \rightarrow t$. If each proper subterm of redex is a normal form, we say the rewriting is innermost. We denote the innermost reduction of the relation $\rightarrow$ as $\rightarrow^{\text {in }}$. We use $\circ$ to denote the composition of two relations. We write $\xrightarrow{*}$ for the reflexive and transitive closure of $\rightarrow$. We also write $\xrightarrow{n}$ for the relation $\rightarrow \circ \cdots \circ \rightarrow$ composed of $n$ $\rightarrow$ 's. The set of reachable terms from a term in $T$ with respect to the relation $\rightarrow$ is defined by $\rightarrow[T]=\left\{t \mid s \in T, s{ }^{*} t\right\}$. The reachability problem (resp. innermost reachability problem) with respect to $\rightarrow$ is the problem that decides whether $s \xrightarrow{*} s^{\prime}$ (resp. $s \xrightarrow{*}$ in $s^{\prime}$ ) or not, for given terms $s$ and $s^{\prime}$.

A mapping $\mu: F \rightarrow \mathcal{P}(\mathbb{N})$ is said to be a replacement map (or $F$-map) if $\mu(f) \subseteq\{1, \ldots, \operatorname{ar}(f)\}$ for all $f \in F$. A context-sensitive term rewriting system (CS-TRS) is the pair $\mathcal{R}=(R, \mu)$ of a TRS and a replacement map. The set of $\mu$ replacing positions $\operatorname{Pos}^{\mu}(t)(\subseteq \operatorname{Pos}(t))$ is recursively defined: $\operatorname{Pos}^{\mu}(t)=\{\varepsilon\}$ if $t$ is a constant or a variable, otherwise $\operatorname{Pos}^{\mu}\left(f\left(t_{1}, \ldots, t_{n}\right)\right)=\{\varepsilon\} \cup\{i p \mid i \in \mu(f), p \in$ $\left.\operatorname{Pos}^{\mu}\left(t_{i}\right)\right\}$. The rewrite relation induced by a CS-TRS $\mathcal{R}$ is defined: $s \underset{\mathcal{R}}{\leftrightarrows} t$ if and only if $s \vec{R}^{p} t$ and $p \in \operatorname{Pos}^{\mu}(t)$. If a term $t$ has no redex at $\operatorname{Pos}^{\mu}(t)$, we say $t$ is a context-sensitive normal form. We denote the set of a context-sensitive normal form of $\mathcal{R}$ as $\mathrm{CS}_{-} \mathrm{NF}_{\mathcal{R}}$. If each proper subterm of redex is a context-sensitive

normal form or not in a $\mu$-replacing position, we say the rewriting with CS-TRS is innermost.

A tree automaton $(\mathrm{TA})$ is a quadruple $\mathcal{A}=\left(F, Q, Q^{f}, \Delta\right)$ where $F$ is a finite set of function symbols, $Q$ is a finite set of states, $Q^{f}(\subseteq Q)$ is a set of final states, and $\Delta$ is a finite set of transition rules of the forms $f\left(q_{1}, \ldots, q_{n}\right) \rightarrow q$ or $q_{1} \rightarrow q$ where $f \in F$ with $\operatorname{ar}(f)=n$, and $q_{1}, \ldots, q_{n}, q \in Q$. We sometimes omit $F$ if it is not necessary to specify explicitly. We can regard $\Delta$ as a (ground) TRS over $F \cup Q$. The rewrite relation induced by $\Delta$ of $\mathcal{A}$ is called a transition relation denoted by $\underset{\Delta}{\longrightarrow}$ or $\xrightarrow[\mathcal{A}]{ }$. We denote $|\alpha|$ as the length of a transition sequence $\alpha$ (if $\alpha$ is $s \xrightarrow{n} t$, then $|\alpha|=n)$. We say that a term $s(\in \mathcal{T}(F))$ is accepted by $q \in Q$ if $s \xrightarrow[\Delta]{*} q$, and if $q \in Q^{f}$, we also say that $s$ is accepted by $\mathcal{A}$. The set of all terms accepted by $\mathcal{A}$ is denoted by $\mathcal{L}(\mathcal{A})$. We say $\mathcal{A}$ recognizes $\mathcal{L}(\mathcal{A})$. A set of terms $T$ is regular if there exists a TA that recognizes $T$. We use a notation $\mathcal{L}(\mathcal{A}, q)$ or $\mathcal{L}(\Delta, q)$ to represent the $\operatorname{set}\{s \mid s \xrightarrow[\Delta]{*} q, s \in \mathcal{T}(F)\}$. A TA $\mathcal{A}$ is deterministic if $s \xrightarrow[\Delta]{*} q$ and $s \xrightarrow[\Delta]{*} q^{\prime}$ implies $q=q^{\prime}$ for any $s \in \mathcal{T}(F)$. A TA $\mathcal{A}$ is complete if there exists $q \in Q$ such that $s \underset{\Delta}{*} q$ for any $s \in \mathcal{T}(F)$. A state $q \in Q$ of $\mathcal{A}$ is accessible if $\mathcal{L}(\mathcal{A}, q) \neq \emptyset$, and if every state in $Q$ is accessible, $\mathcal{A}$ is reduced.

A tree automaton with constraints between brothers (TACBB) is a extended TA in which transition rules have constraints between brothers. Constraints between brothers are recursively defined: $\top, \perp$, equality $i=j$, and disequality $i \neq j$ are constraints between brothers where $i, j \in \mathbb{N}$, and if $c_{1}$ and $c_{2}$ are constraints between brothers, then a conjunction $c_{1} \wedge c_{2}$ and a disjunction $c_{1} \vee c_{2}$ are also constraints between brothers. A term $f\left(t_{1}, \ldots, t_{n}\right)$ satisfies the constraints between brothers $c$ if $c$ is true by assigning true to $\top$, equality $i=j$ if $t_{i}=t_{j}$, and disequality $i \neq j$ if $t_{i} \neq t_{j}$, and false to $\perp$, equality $i=j$ if $t_{i} \neq t_{j}$, and disequality $i \neq j$ if $t_{i}=t_{j}$. Each transition rule is of the form $f\left(q_{1}, \ldots, q_{n}\right) \xrightarrow{c} q$ or $q_{1} \xrightarrow{\top} q$ where $c$ is a constraint between brothers. A term $f\left(t_{1}, \ldots, t_{n}\right)$ can reach to a state $q$ by the transition rule $f\left(q_{1}, \ldots, q_{n}\right) \xrightarrow{c} q \Delta$ of a TACBB if $t_{i} \xrightarrow[\Delta]{*} q_{i}$ for $1 \leq i \leq n$ and $f\left(t_{1}, \ldots, t_{n}\right)$ satisfies $c$.

The following properties on TA and TACBB are known ${ }^{3)}$.
Theorem 1 All of the following holds for TAs and TACBBs:
(1) For a given $\mathrm{TA}(\mathrm{TACBB}) \mathcal{A}$, there exists a deterministic complete reduced

TA (TACBB) $\mathcal{A}^{\prime}$ that recognizes $\mathcal{L}(\mathcal{A})$.
(2) The class of recognizable tree languages is closed under union, intersection, and complementation.
(3) The membership problem and the emptiness problem are decidable.

## 3. Decidability of Reachability for Right-linear Right-shallow CSTRSs

In this section, we prove that reachability for right-linear right-shallow CSTRSs is decidable. To this end, we show the algorithm $\mathrm{P}_{\mathrm{cs}}$ that constructs a tree automaton recognizing the set of terms reachable by a right-linear right-shallow CS-TRS from an input term.
The algorithm $\mathrm{P}_{\mathrm{cs}}$ is based on the algorithm in Ref.9). In Ref.9), if a term $t$ matches both a rewrite rule and a transition rule, then we produce transition rules to accept the term obtained by the rewriting. For example, if we have the rewrite rule $a \rightarrow b$ and the transition rule $a \rightarrow q$, then we produce the transition rule $b \rightarrow q$. However this algorithm can only deal with linear right-shallow TRSs. Therefore, we introduce the ideas in Refs. 14) and 17) to deal with the left-nonlinear system, and the idea in Ref. 10) to deal with context-sensitive TRSs.
In Refs. 14) and 17), to deal with left-non-linear TRSs, we use subsets of the set of states of input automata as the set of states of output automata. In Ref. 10), to deal with context-sensitive TRSs, each state $q$ of input automata is divided to $\langle q$, a $\rangle$ and $\langle q, i\rangle^{\star 1}$. We merge and modify these ideas to deal with right-linear right-shallow CS-TRSs. We show an example of automata construction in the following where it can be seen that the automaton obtained by $\mathrm{P}_{\mathrm{cs}}$ recognizes the set of terms reachable from an input term correctly.

Example 2 Let $R=\{a \rightarrow b, b \rightarrow d, c \rightarrow d, f(x, x) \rightarrow g(x, c), g(x, x) \rightarrow$ $h(x)\}, \mu(f)=\{1\}, \mu(g)=\{1,2\}, \mu(h)=\emptyset$, and $\mathcal{A}=\left\langle Q, Q^{f}, \Delta\right\rangle$ where $Q=\left\{q^{a}, q^{b}, q^{c}, q^{f(a, b)}\right\}, Q^{f}=\left\{q^{f(a, b)}\right\}, \Delta=\left\{a \rightarrow q^{a}, b \rightarrow q^{b}, c \rightarrow\right.$ $\left.q^{c}, f\left(q^{a}, q^{b}\right) \rightarrow q^{f(a, b)}\right\}$, and hence $\mathcal{L}(\mathcal{A})=\{f(a, b)\}$. $\mathrm{P}_{\text {cs }}$ output the automaton $\mathcal{A}_{*}=\left\langle Q_{*}, Q_{*}^{f}, \Delta_{*}\right\rangle$ that recognizes $\underset{\mathcal{R}}{\longrightarrow}[\{f(a, b)\}]$.

The set of states $Q_{*}$ is the set $\{\langle P, \mathrm{a}\rangle,\langle\{p\}, \mathrm{i}\rangle\}$ where $P \subseteq Q, P \neq \emptyset$, and $p \in Q, Q_{*}^{f}$ is $\left\{\left\langle P^{f}, \mathrm{a}\right\rangle \mid P^{f} \subseteq Q, P^{f} \cap Q^{f} \neq \emptyset\right\}$ and the set of transition rules $\Delta_{*}$ is

where $P_{1} \subseteq\left\{q^{a}, q^{b}, q^{c}\right\}$ and $\mathrm{x} \in\{\mathrm{a}, \mathrm{i}\}$. We obtain $\mathcal{L}\left(\mathcal{A}_{*}\right)=$ $\{f(a, b), f(b, b), f(d, b), g(b, c), g(d, c), g(b, d), g(d, d), h(d)\}=\underset{\mathcal{R}}{\longrightarrow}[\mathcal{L}(\mathcal{A})]$

Here we describe Example 2. First, we obtain $Q_{*}$ by augmenting parameter a or i to each state and taking subset of $Q$ for the first components of the states. From the set of transition rules $\Delta_{*}$, it can be seen that $\left\langle\left\{q^{a}\right\}, \mathbf{i}\right\rangle,\left\langle\left\{q^{b}\right\}, \mathbf{i}\right\rangle,\left\langle\left\{q^{c}\right\}, \mathbf{i}\right\rangle$, and $\left\langle\left\{q^{f(a, b)}\right\}\right.$, i $\rangle$ only accept the terms accepted by $q^{a}, q^{b}, q^{c}$ and $q^{f(a, b)}$, and $\left\langle\left\{q^{a}\right\}, \mathrm{a}\right\rangle,\left\langle\left\{q^{b}\right\}, \mathrm{a}\right\rangle,\left\langle\left\{q^{c}\right\}, \mathrm{a}\right\rangle$, and $\left\langle\left\{q^{f(a, b)}\right\}\right.$, a $\rangle$ accept the terms reachable by $\mathcal{R}$ from the terms accepted by $q^{a}, q^{b}, q^{c}$, and $q^{f(a, b)}$, that is $a, b, c$, and $f(a, b)$, respectively. From $\mu(f)=\{1\}$, the state in the second argument of $f$ in the transition rule must have $i$ as its second component. In this way, $\mathcal{A}_{*}$ does not accepts the terms obtained by rewriting the second argument of $f$. Moreover, we have $\mathcal{L}\left(\mathcal{A}_{*},\left\langle\left\{q^{b}, q^{c}\right\}\right.\right.$, a $\left.\rangle\right)=\left(\mathcal{L}\left(\mathcal{A}_{*},\left\langle\left\{q^{b}\right\}\right.\right.\right.$, a $\left.\rangle\right) \cap \mathcal{L}\left(\mathcal{A}_{*},\left\langle\left\{q^{c}\right\}\right.\right.$, a $\left.\left.\rangle\right)\right)$. Indeed, the state $\left\langle\left\{q^{b}, q^{c}\right\}, \mathrm{a}\right\rangle$ accepts only $d$, and the term reachable from $b$ and $c$ is only $d$, too. Since the term that is reachable from $f(a, b)$ and matches $f(x, x)$ is only $f(b, b)$, we produce the transition rule $g\left(\left\langle\left\{q^{b}\right\}, \mathrm{a}\right\rangle,\left\langle\left\{q^{c}\right\}, \mathrm{a}\right\rangle\right) \rightarrow\left\langle\left\{q^{f(a, b)}\right\}\right.$, a $\rangle$ from the rewrite rule $f(x, x) \rightarrow g(x, c)$. Since the term that is reachable from $f(a, b)$ and matches $g(x, x)$ is only $g(d, d)$, we produce the transition rule $h\left(\left\langle\left\{q^{b}, q^{c}\right\}, \mathrm{a}\right\rangle\right) \rightarrow$ $\left\langle\left\{q^{f(a, b)}\right\}\right.$, a $\rangle$ from the rewrite rule $g(x, x) \rightarrow h(x)$.
Concrete definition of the algorithm $\mathrm{P}_{\mathrm{cs}}$ is the following.

## Algorithm $\mathbf{P}_{\text {cs }}$ :

Input A term $t$ and a right-shallow CS-TRS $\mathcal{R}=(R, \mu)$.

Output The TA $\mathcal{A}_{*}=\left\langle Q_{*}, Q_{*}^{f}, \Delta_{*}\right\rangle$ such that $\mathcal{L}\left(\mathcal{A}_{*}\right)=\underset{\mathcal{R}}{\hookrightarrow}[\{t\}]$, if $\mathcal{R}$ is rightlinear.
Step 1 (initialize) (1) Prepare a TA $\mathcal{A}=\left\langle Q, Q^{f}, \Delta\right\rangle$ where each state $q^{s}$ accepts $s \in\{t\} \cup \operatorname{RS}(R)$, and $\operatorname{RS}(R)$ is the set of a proper ground subterm of the right-hand sides of $R$. Here we assume $Q=\left\{q^{s} \mid s \unlhd s^{\prime}, s^{\prime} \in\{t\} \cup \operatorname{RS}(R)\right\}$, $Q^{f}=\left\{q^{t}\right\}$, and $\mathcal{L}\left(\mathcal{A}_{\mathrm{RS}}, q^{s}\right)=\{s\}$ for all $q^{s}$.
(2) Let

- $k:=0$,
- $Q_{*}:=\{P(\subseteq Q) \mid P \neq \emptyset\} \times\{\mathrm{a}\} \cup\{\{q\} \mid q \in Q\} \times\{\mathrm{i}\}$,
- $Q_{*}^{f}=\left\{P^{f}(\subseteq Q) \mid P^{f} \cap Q^{f} \neq \emptyset\right\} \times\{\mathrm{a}\}$, and

Step 2 Let $\Delta_{k+1}$ be the set of transition rules produced by augmenting transition rules of $\Delta_{k}$ by the following inference rules. Let $C$ be the context that has no variable:
(1) If there exists $\sigma: X \rightarrow T(F)$ such that $x_{i} \sigma \xrightarrow[\Delta_{k}]{*}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$ for all $1 \leq i \leq n$, we apply the following inference rule:

(2) If there exists $\sigma: X \rightarrow T(F)$ such that $x_{i} \sigma \stackrel{*}{\Delta_{k}}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$ for all $1 \leq i \leq n$, we apply the following inference rule:

Step 3 For all states $\left\langle P^{1} \cup P^{2}\right.$, a $\rangle \in Q_{*}$ where $P^{1} \neq P^{2}$, we add new transition rule to $\Delta_{k+1}$ as follows:
(1) $f\left(\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right) \rightarrow\left\langle P^{1} \cup P^{2}, \mathrm{a}\right\rangle \in \Delta_{k+1}$ where

- $\mathrm{x}_{i}=\left\{\begin{array}{l}\mathrm{a} \cdots \text { if } \mathrm{x}_{i}^{1}=\mathrm{x}_{i}^{2}=\mathrm{a}, \text { and } \\ \mathrm{i} \cdots \text { if otherwise. }\end{array}\right.$
if $f\left(\left\langle P_{1}^{j}, \mathrm{x}_{1}^{j}\right\rangle, \ldots,\left\langle P_{n}^{j}, \mathrm{x}_{n}^{j}\right\rangle\right) \rightarrow\left\langle P^{j}, \mathrm{a}\right\rangle \in \Delta_{k}$ for $j \in\{1,2\}$.
Note that if $\mathcal{L}\left(\Delta_{k},\left\langle P_{i}^{1}, \mathrm{x}_{i}^{1}\right\rangle\right) \cap \mathcal{L}\left(\Delta_{k},\left\langle P_{i}^{2}, \mathrm{x}_{i}^{2}\right\rangle\right)=\emptyset$ and $\mathrm{x}_{i}^{j}=\mathrm{i}$ for some $j \in\{1,2\}$, then the transition rule is not produced.
(2) $\left\langle P_{1}^{\prime} \cup P_{2}^{\prime}\right.$, a $\rangle \rightarrow\left\langle P_{1} \cup P_{2}\right.$, a $\rangle \in \Delta_{k+1}$ if $\left\langle P_{1}^{\prime}\right.$, a $\rangle \rightarrow\left\langle P_{1}\right.$, a $\rangle \in \Delta_{k}$, and, $\left\langle P_{2}^{\prime}, \mathrm{a}\right\rangle \rightarrow\left\langle P_{2}, \mathrm{a}\right\rangle \in \Delta_{k}$ or $P_{2}^{\prime}=P_{2}$.
Step 4 If $\Delta_{k+1}=\Delta_{k}$ then stop and set $\Delta_{*}:=\Delta_{k}$; Otherwise $k:=k+1$ and go to Step 2.

Example 3 Let us follow how the algorithm $\mathrm{P}_{\mathrm{cs}}$ works. We input the rightlinear right-shallow CS-TRS $\mathcal{R}$ of Example 2 and the term $f(a, b)$.
In the initializing step, at (1) of Step 1 , we construct the automaton $\mathcal{A}$ of Example 2, and at (2) of Step 1, we have $Q_{*}=\{\langle P, \mathrm{a}\rangle,\langle\{p\}, \mathrm{i}\rangle\}$ where $P \subseteq Q$, $P \neq \emptyset$, and $p \in Q, Q_{*}^{f}=\left\{\left\langle P_{f}, \mathrm{a}\right\rangle\right\}$ where $P_{f} \subseteq Q$ and $P_{f} \cap Q^{f} \neq \emptyset$, and $\Delta_{0}=\left\{a \rightarrow\left\langle\left\{q^{a}\right\}, \mathrm{x}\right\rangle, b \rightarrow\left\langle\left\{q^{b}\right\}, \mathbf{x}\right\rangle, f\left(\left\langle\left\{q^{a}\right\}, \mathrm{x}\right\rangle,\left\langle\left\{q^{b}\right\}, \mathbf{i}\right\rangle\right) \rightarrow\left\langle\left\{q^{f(a, b)}\right\}, \mathrm{x}\right\rangle\right\}$ where $\mathrm{x} \in\{\mathrm{a}, \mathrm{i}\}$.
In the saturation step at $k=0$, we produce the transition rules $\{b \rightarrow$ $\left.\left\langle\left\{q^{a}\right\}, \mathrm{a}\right\rangle, d \rightarrow\left\langle\left\{q^{b}\right\}, \mathrm{a}\right\rangle, d \rightarrow\left\langle\left\{q^{c}\right\}, \mathrm{a}\right\rangle, g\left(\left\langle\left\{q^{b}\right\}, \mathrm{a}\right\rangle,\left\langle\left\{q^{a}\right\}, \mathrm{a}\right\rangle\right) \rightarrow\left\langle\left\{q^{f(a, b)}\right\}, \mathrm{a}\right\rangle\right\}$ at Step 2.

At $k=1$, we produce the transition rules $\left\{d \rightarrow\left\langle\left\{q^{a}\right\}, \mathrm{a}\right\rangle, h\left(\left\langle\left\{q^{b}, q^{c}\right\}, \mathrm{a}\right\rangle\right) \rightarrow\right.$ $\left.\left\langle\left\{q^{f(a, b)}\right\}, \mathrm{a}\right\rangle\right\}$ at Step 2 and $\left\{b \rightarrow\left\langle\left\{q^{a}, q^{b}\right\}, \mathrm{a}\right\rangle, d \rightarrow\left\langle\left\{q^{b}, q^{c}\right\}, \mathrm{a}\right\rangle\right\}$ at Step 3.

At $k=2$, we produce the transition rules $\left\{d \rightarrow\left\langle\left\{q^{a}, q^{b}\right\}, \mathrm{a}\right\rangle, d \rightarrow\right.$ $\left.\left\langle\left\{q^{a}, q^{c}\right\}, \mathrm{a}\right\rangle, d \rightarrow\left\langle\left\{q^{a}, q^{b}, q^{c}\right\}, \mathrm{a}\right\rangle\right\}$ at Step 3.

The saturation steps stop at $k=3$, and we have $\Delta_{*}=\Delta_{3}$.
The algorithm $\mathrm{P}_{\mathrm{cs}}$ eventually terminates at some $k$, because rewrite rules in $R$ and states in $Q_{*}$ are finite and hence possible transitions rules are finite. Apparently $\Delta_{0} \subset \cdots \subset \Delta_{k}=\Delta_{k+1}=\cdots$.
Here we have two remarks.
Our first remark is that the state in which the second parameter is a does not always occur at rewritable positions. In Example 3, we have both $\mu(h)=\emptyset$ and the transition rule $h\left(\left\langle\left\{q^{b}, q^{c}\right\}, \mathrm{a}\right\rangle\right) \rightarrow\left\langle q^{f(a, b)}, \mathrm{a}\right\rangle$. However, this causes no problem. Indeed, the rewriting $h(b) \underset{\mathcal{R}}{\longrightarrow} h(c)$ is forbidden but $h(c)$ is reachable from $g(b)$ as $g(b) \underset{\mathcal{R}}{\leftrightarrows} g(c) \underset{\mathcal{R}}{\leftrightarrows} h(c)$.
Our second remark is that the former part of the input for $\mathrm{P}_{\mathrm{cs}}$ is a term while it is an arbitrary tree automaton in Refs. 14), 17), and 10). Otherwise, $\mathrm{P}_{\mathrm{cs}}$ may output an incorrect automaton as shown in the following example:

Example 4 Let $R$ be $\{a \rightarrow b, a \rightarrow d, c \rightarrow d, f(x, x) \rightarrow g(x)\}, \mu(f)=\mu(g)=$ $\{1\}$, and $\mathcal{A}=\left\langle Q, Q^{f}, \Delta\right\rangle$ where $Q=\left\{q_{1}, q_{2}, q^{f}\right\}, Q^{f}=\left\{q^{f}\right\}, \Delta=\left\{a \rightarrow q_{1}, b \rightarrow\right.$ $\left.q_{2}, c \rightarrow q_{2}, f\left(q_{1}, q_{2}\right) \rightarrow q^{f}\right\}$, and hence $\mathcal{L}(\mathcal{A})=\{f(a, b), f(a, c)\}$. Thus, $\underset{\mathcal{R}}{\stackrel{*}{\longrightarrow}}[\mathcal{L}(\mathcal{A})]$ is the set $\{f(a, b), f(b, b), f(d, b), f(a, c), f(b, c), f(d, c), g(b)\}$.
Then, $\mathrm{P}_{\mathrm{cs}}$ output the automaton $\mathcal{A}_{*}$ of which transition rules in $\Delta_{*}$ are $\left\{a \rightarrow\left\langle\left\{q_{1}\right\}, \mathrm{x}\right\rangle, b \rightarrow\left\langle\left\{q_{2}\right\}, \mathrm{i}\right\rangle, b \rightarrow\langle P, \mathrm{a}\rangle, c \rightarrow\left\langle\left\{q_{2}\right\}, \mathrm{x}\right\rangle, d \rightarrow\right.$ $\left.\langle P, \mathrm{a}\rangle, f\left(\left\langle\left\{q_{1}\right\}, \mathrm{x}\right\rangle,\left\langle\left\{q_{2}\right\}, \mathrm{i}\right\rangle\right) \rightarrow\left\langle\left\{q^{f}\right\}, \mathrm{x}\right\rangle, g\left(\left\langle\left\{q_{2}\right\}, \mathrm{a}\right\rangle\right) \rightarrow\left\langle\left\{q^{f}\right\}, \mathrm{a}\right\rangle\right\}$ where $P \in$ $\left\{\left\{q_{1}\right\},\left\{q_{2}\right\},\left\{q_{1}, q_{2}\right\}\right\}$ and $\mathrm{x} \in\{\mathrm{a}, \mathrm{i}\}$. Hence, $\mathcal{A}_{*}$ accepts the terms $g(d)$ that is not in $\underset{\mathcal{R}}{\stackrel{*}{\rightarrow}}[\mathcal{L}(\mathcal{A})]$.

As for Example 4, preparing another state that accepts only $b$ to construct a correct automaton is enough. However, guaranteeing the termination of a procedure if a new state is added in the procedure is difficult.
In the following, we show the correctness of $\mathrm{P}_{\mathrm{cs}}$.
First, we show several propositions that are trivially derived from the definition
of $\mathrm{P}_{\mathrm{cs}}$.

Proposition 5 Let $t \in \mathcal{T}(F)$. For $q^{t} \in Q, t \xrightarrow[\Delta_{0}]{*}\left\langle\left\{q^{t}\right\}\right.$, i $\rangle$ iff $t \xrightarrow[\Delta]{*} q^{t}$.
Proof: Direct consequence of the construction of $\Delta$, and $\Delta_{0}$.

Proposition 6 Let $t \in \mathcal{T}(F)$. For any $k$, if $t \xrightarrow[\Delta_{k}]{*}\langle P, i\rangle \in Q_{*}$, then $t \xrightarrow[\Delta_{0}]{*}\langle P, i\rangle$. Moreover, $P$ is of the form $\{q\}$.

Proof: The first claim follows from the fact that the transition rules in which right-hand-sides is the state having i are not added at Step 2 or Step 3. The second claim follows from the construction of states.

Proposition 7 Let $t \in \mathcal{T}(F)$. Then, $t \underset{\Delta_{0}}{*}\langle P, \mathrm{i}\rangle \in Q_{*}$ iff $t \xrightarrow[\Delta_{0}]{*}\langle P, \mathrm{a}\rangle \in Q_{*}$.
Proof: Direct consequence of the construction of $\Delta_{0}$.
Proposition 8 Let $t \in \mathcal{T}(F)$. For any $k$, If $t \xrightarrow[\Delta_{k}]{*}\langle P, \mathbf{i}\rangle$, then $t \xrightarrow[\Delta_{k}]{*}\langle P, \mathrm{a}\rangle$.
Proof: Let $t \xrightarrow[\Delta_{k}]{*}\langle P, \mathbf{i}\rangle$, then $t \xrightarrow[\Delta_{0}]{*}\langle P, \mathbf{i}\rangle$ from Proposition 6. This proposition follows from Proposition 7 and $\Delta_{0} \subseteq \Delta_{k}$.
Next we show several technical lemmas. Lemmas 9, 10, 12, and 14 below are necessary to prove Lemmas 15 and 19 that are key lemmas to prove completeness and soundness. Lemmas 11 and 13 are auxiliary lemmas for Lemmas 12 and 14, respectively.

Lemma 9 Let $s, t \in \mathcal{T}(F), s \xrightarrow[\Delta_{0}]{*}\langle P, \mathrm{x}\rangle$, and $t \xrightarrow[\Delta_{0}]{*}\left\langle P^{\prime}, \mathrm{x}^{\prime}\right\rangle$. Then, $P=P^{\prime}$ iff $s=t$.

Proof: First we have s $\underset{\Delta_{0}}{*}\langle P, \mathrm{i}\rangle, t \underset{\Delta_{0}}{*}\left\langle P^{\prime}, \mathrm{i}\right\rangle, P=\{q\}$, and $P^{\prime}=\left\{q^{\prime}\right\}$ for some $q, q^{\prime} \in Q$ from Proposition 6 and Proposition 7. Then, we have $s \stackrel{\Delta_{\Delta}}{\Delta} q^{s}=q$ and $t \stackrel{*}{\Delta} q^{t}=q^{\prime}$ from Proposition 5 and the construction of $\mathcal{A}$. Thus, we have $P=P^{\prime}$ iff $s=t$.

Lemma 10 If $\alpha: t\left[t^{\prime}\right]_{p} \xrightarrow[\Delta_{*}]{*}\langle P, a\rangle$ and $p \in \operatorname{Pos}^{\mu}(t)$, then there exists $\left\langle P^{\prime}\right.$, a $\rangle$ such that $t^{\prime} \xrightarrow[\Delta_{*}]{*}\left\langle P^{\prime}\right.$, a $\rangle$ and $t\left[\left\langle P^{\prime}, \mathrm{a}\right\rangle\right]_{p} \xrightarrow[\Delta_{*}]{*}\langle P, \mathrm{a}\rangle$.

Proof: We show this lemma by induction on $|\alpha|$. Let $p \in \operatorname{Pos}^{\mu}(t)$,
(1) If $p=\varepsilon$, then $t=t^{\prime}$, and hence $t^{\prime} \xrightarrow[\Delta_{*}]{*}\langle P, \mathrm{a}\rangle$ follows.
(2) Consider the case $p=i p^{\prime}$ for some $i \in \mathbb{N}$. Then $\alpha$ can be represented as $t\left[t^{\prime}\right]_{p} \stackrel{*}{\Delta_{*}}\left\langle P^{\prime}\right.$, a $\rangle \xrightarrow[\Delta_{*}]{\longrightarrow}\langle P$, a $\rangle$ or $t\left[t^{\prime}\right]_{p}=f\left(\ldots, t_{i-1}, t_{i}\left[t^{\prime}\right]_{p^{\prime}}, t_{i+1}, \ldots\right) \xrightarrow[\Delta_{*}]{*}$ $f\left(\ldots,\left\langle P_{i-1}, \mathrm{x}_{i-1}\right\rangle,\left\langle P_{i}, \mathrm{x}_{i}\right\rangle,\left\langle P_{i+1}, \mathrm{x}_{i+1}\right\rangle, \ldots\right) \underset{\Delta_{*}}{\longrightarrow}\langle P, \mathrm{a}\rangle$.
In the former case, this lemma holds from the induction hypothesis.
In the latter case, since $i p^{\prime}=p \in \operatorname{Pos}^{\mu}(t)$, we have $i \in \mu(f)$. Hence $\mathbf{x}_{i}=\mathrm{a}$ follows from the construction of $\Delta_{*}$.
From the induction hypothesis, there exists $\left\langle P^{\prime}, \mathrm{a}\right\rangle \in Q_{*}$ such that $t^{\prime} \xrightarrow[\Delta_{*}]{*}\left\langle P^{\prime}\right.$, a $\rangle$ and $t_{i}\left[\left\langle P^{\prime}, \mathrm{a}\right\rangle\right]_{p^{\prime}} \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}\right.$, a $\rangle$. Thus we have $t\left[\left\langle P^{\prime}, \mathrm{a}\right\rangle\right]_{p}=$ $f\left(\ldots, t_{i-1}, t_{i}\left[\left\langle P^{\prime}, \mathrm{a}\right\rangle\right]_{p^{\prime}}, t_{i+1}, \ldots\right) \xrightarrow[\Delta_{*}]{\stackrel{*}{\Delta_{*}}} \quad f\left(\ldots,\left\langle P_{i-1}, \mathrm{x}_{i-1}\right\rangle,\left\langle P_{i}, \mathrm{a}\right\rangle,\left\langle P_{i+1}\right.\right.$, $\left.\left.\mathrm{x}_{i+1}\right\rangle, \ldots\right) \underset{\Delta_{*}}{\longrightarrow}\langle P, \mathrm{a}\rangle$.

Lemma 11 If $\left\langle P_{1}^{\prime}\right.$, a $\rangle \xrightarrow[\Delta_{*}]{*}\left\langle P_{1}\right.$, a $\rangle$ and $\left\langle P_{2}^{\prime}\right.$, a $\rangle \xrightarrow[\Delta_{*}]{*}\left\langle P_{2}\right.$, a $\rangle$, then we have $\left\langle P_{1}^{\prime} \cup\right.$ $P_{2}^{\prime}$, a $\rangle \xrightarrow[\Delta_{*}]{*}\left\langle P_{1} \cup P_{2}\right.$, a $\rangle$.

Proof: We can assume $\left\langle P_{1}^{\prime}\right.$, a $\rangle \underset{\Delta_{*}}{n}\left\langle P_{1}\right.$, a $\rangle$ and $\left\langle P_{2}^{\prime}\right.$, a $\rangle \xrightarrow[\Delta_{*}]{n}\left\langle P_{2}^{\prime \prime}\right.$, a $\rangle \xrightarrow[\Delta_{*}]{*}\left\langle P_{2}\right.$, a $\rangle$ without loss of generality.
First, we prove the claim that $\left\langle P_{1}^{\prime} \cup P_{2}^{\prime}\right.$, a $\rangle \stackrel{*}{\Delta_{*}}\left\langle P_{1} \cup P_{2}^{\prime \prime}\right.$, a $\rangle$. If $n=0$, the claim trivially holds. If $n=1$, the claim holds from (2) of Step 3 of $\mathrm{P}_{\text {cs }}$. If $n>1$, the claim holds by repeating the process for $n=1$.
Moreover, we can show the claim that $\left\langle P_{1} \cup P_{2}^{\prime \prime}\right.$, a $\rangle \underset{\Delta_{*}}{*}\left\langle P_{1} \cup P_{2}\right.$, a $\rangle$ similarly to the previous claim.

Lemma 12 If $t \underset{\Delta_{*}^{*}}{\stackrel{*}{*}}\left\langle P^{j}, \mathrm{a}\right\rangle$ for $1 \leq j \leq m$, then we have $t \xrightarrow[\Delta_{*}]{*}\left\langle\bigcup_{1 \leq j \leq m} P^{j}\right.$, a $\rangle$.
Proof: The proof for $m=1$ is trivial. We show the proof for $m=2$ by induction on $|t|$. By applying the proof for $m=2$ repeatedly, we can show this lemma.
Let $t=f\left(t_{1}, \ldots, t_{n}\right)$. Then, each transition sequence is represented as $f\left(t_{1}, \ldots, t_{n}\right) \xrightarrow[\Delta_{*}]{*} f\left(\left\langle P_{1}^{j}, \mathrm{x}_{1}^{j}\right\rangle, \ldots,\left\langle P_{n}^{j}, \mathrm{x}_{n}^{j}\right\rangle\right) \xrightarrow[\Delta_{*}]{\longrightarrow}\left\langle P_{r}^{j}, \mathrm{a}\right\rangle \stackrel{*}{\Delta_{*}}\left\langle P^{j}, \mathrm{a}\right\rangle$ for $j \in\{1,2\}$. From Lemma 11, we have $\left\langle P_{r}^{1} \cup P_{r}^{2}, \mathrm{a}\right\rangle \xrightarrow[\Delta_{*}]{*}\left\langle P^{1} \cup P^{2}, \mathrm{a}\right\rangle$. Therefore, we show that $f\left(t_{1}, \ldots, t_{n}\right) \xrightarrow[\Delta_{*}]{*}\left\langle P_{r}^{1} \cup P_{r}^{2}, \mathrm{a}\right\rangle$.

From (1) of Step 3 of $\mathrm{P}_{\mathrm{cs}}$, we have the transition rule $f\left(\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right) \rightarrow$ $\left\langle P_{r}^{1} \cup P_{r}^{2}, \mathrm{a}\right\rangle \in \Delta_{*}$ where

- $P_{i}= \begin{cases}P_{i}^{j} & \cdots \text { if } \mathrm{x}_{i}^{j}=\mathrm{i} \text { for some } j \in\{1,2\}, \text { and } \\ P_{i}^{1} \cup P_{i}^{2} & \cdots \text { if } \mathrm{x}_{i}^{1}=\mathrm{x}_{i}^{2}=\mathrm{a} .\end{cases}$
- $\mathrm{x}_{i}=\left\{\begin{array}{l}\mathrm{a} \cdots \text { if } \mathrm{x}_{i}^{1}=\mathrm{x}_{i}^{2}=\mathrm{a}, \text { and } \\ \mathrm{i} \cdots \text { otherwise. }\end{array}\right.$

Here we show that $t_{i} \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}, \mathbf{x}_{i}\right\rangle$ for $1 \leq i \leq n$.

- For $i$ such that $\mathrm{x}_{i}=\mathrm{i}, P_{i}$ is $P_{i}^{1}$ or $P_{i}^{2}$ and hence we have $t_{i} \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$.
- For $i$ such that $\mathrm{x}_{i}=\mathrm{a}, P_{i}$ is $P_{i}^{1} \cup P_{i}^{2}$ and hence we have $t_{i} \xrightarrow[\Delta_{*}]{\Delta_{*}}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$ from the induction hypothesis.
Thus, we have the transition $f\left(t_{1}, \ldots, t_{n}\right) \xrightarrow[\Delta_{*}]{*} f\left(\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right) \xrightarrow[\Delta_{*}]{\longrightarrow}$ $\left\langle P_{r}, \mathrm{a}\right\rangle \underset{\Delta_{*}}{*}\langle P, \mathrm{a}\rangle$.

Lemma 13 If $\left\langle P_{1}\right.$, a $\rangle \underset{\Delta_{*}}{*}\langle P$, a $\rangle$, then there exists $P_{1}^{\prime} \subseteq P_{1}$ such that $\left\langle P_{1}^{\prime}, \mathrm{a}\right\rangle \stackrel{*}{\Delta_{*}}$ $\left\langle P^{\prime}\right.$, a for all $P^{\prime} \subseteq P$ where $P^{\prime} \neq \emptyset$.

Proof: By the induction on $|P|+\left|P_{1}\right|$, we show the proof for the case of $\left\langle P_{1}, \mathrm{a}\right\rangle \underset{\Delta_{*}}{\longrightarrow}\langle P, \mathrm{a}\rangle$. If $\left\langle P_{1}, \mathrm{a}\right\rangle=\langle P, \mathrm{a}\rangle$, then this lemma holds trivially. If $\left|\left\langle P_{1}, \mathrm{a}\right\rangle \xrightarrow[\Delta_{*}]{\stackrel{\Delta}{*}}\langle P, \mathrm{a}\rangle\right|>1$, then we can prove this lemma by applying the proof for $\left\langle P_{1}, \mathrm{a}\right\rangle \underset{\Delta_{*}}{\longrightarrow}\langle P, \mathrm{a}\rangle$.
Let $P^{\prime}=P \backslash P^{\prime \prime}$. We show that if $P_{1}^{\prime}$ exists such that $\left\langle P_{1}^{\prime}\right.$, a $\rangle \xrightarrow[\Delta_{*}]{*}\left\langle P^{\prime}\right.$, a $\rangle$ where $P_{1}^{\prime} \subseteq P_{1}$. If $|P|=1$, then the claim holds trivially. If $|P|>1$, we can assume that the transition rule $\left\langle P_{1}, \mathrm{a}\right\rangle \rightarrow\langle P, \mathrm{a}\rangle \in \Delta_{*}$ is produced by the rules $\left\langle P_{1}^{j}\right.$, à $\rightarrow\left\langle P^{j}\right.$, a $\rangle \in \Delta_{*}$ where $j \in\{1,2\}, P^{1} \cup P^{2}=P$, and $P_{1}^{1} \cup P_{1}^{2}=P_{1}$ by (2) of Step 3 of $\mathrm{P}_{\mathrm{cs}}$. Note that we have $\left|P^{j}\right|+\left|P_{1}^{j}\right|<|P|+\left|P_{1}\right|$ for $j \in\{1,2\}$ because if $\left|P^{j}\right|+\left|P_{1}^{j}\right|=|P|+\left|P_{1}\right|$ then we have $P^{1}=P^{2}$ and $P_{1}^{1}=P_{1}^{2}$, and hence the rule $\left\langle P_{1}, \mathrm{a}\right\rangle \rightarrow\langle P, \mathrm{a}\rangle \in \Delta_{*}$ is the same as $\left\langle P_{1}^{j}, \mathrm{a}\right\rangle \rightarrow\left\langle P^{j}, \mathrm{a}\right\rangle \in \Delta_{*}$ for $j \in\{1,2\}$.

Let $P_{r}^{\prime}=P_{\mathrm{r}} \backslash P_{\mathrm{r}}^{\prime \prime}$. We show the claim by induction on $\sum_{i=1}^{n}\left|P_{i}\right|+\left|P_{\mathbf{r}}\right|$ and $|t|$. If $\left|P_{\mathrm{r}}\right|=1$, then the claim holds trivially. If $\left|P_{\mathrm{r}}\right|>1$, the transition rule $f\left(\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right) \rightarrow\left\langle P_{\mathrm{r}}, \mathrm{a}\right\rangle$ is produced from the transition rules $f\left(\left\langle P_{1}^{j}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}^{j}, \mathrm{x}_{n}\right\rangle\right) \rightarrow\left\langle P_{\mathrm{r}}^{j}, \mathrm{a}\right\rangle$ where $j \in\{1,2\}$ by (1) of Step 3 of $\mathrm{P}_{\mathrm{cs}}$ and $P_{\mathrm{r}}, P_{i}$ 's, and $\mathrm{x}_{i}$ 's are represented as follows:

- $P_{r}=P_{r}^{1} \cup P_{r}^{2}$,
- $P_{i}= \begin{cases}P_{i}^{j} & \cdots \text { if } x_{i}^{j}=i \\ P_{i}^{1} & \text { for some } j \in\{1,2\} \text {, and }\end{cases}$
- $P_{i}=\left\{\begin{array}{l}P_{i}^{1} \cup P_{i}^{2} \cdots \text { if } \mathrm{x}_{i}^{1}=\mathrm{x}_{i}^{2}=\mathrm{a} .\end{array}\right.$
- $\mathrm{x}_{i}=\left\{\begin{array}{l}\mathrm{a} \cdots \text { if } \mathrm{x}_{i}^{1}=\mathrm{x}_{i}^{2}=\mathrm{a}, \text { and } \\ \mathrm{i} \cdots \text { otherwise. }\end{array}\right.$

Here, we show that $t \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}^{j}, \mathrm{x}_{i}^{j}\right\rangle$ for $j \in\{1,2\}$ and $1 \leq i \leq n$.

- For $i$ such that $\mathrm{x}_{i}=\mathrm{a}$, we have $\mathrm{x}_{i}^{j}=\mathrm{a}$ and $P_{i}^{j} \subseteq P_{i}$. Thus, we have $t \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}^{j}, \mathrm{x}_{i}^{j}\right\rangle$ from the induction hypothesis.
- For $i$ such that $\mathrm{x}_{i}=\mathrm{i}$, we have $\mathcal{L}\left(\Delta_{*},\left\langle P_{i}^{1}, \mathrm{x}_{i}^{1}\right\rangle\right) \cap \mathcal{L}\left(\Delta_{*},\left\langle P_{i}^{2}, \mathrm{x}_{i}^{2}\right\rangle\right) \neq \emptyset$, and, $\mathrm{x}_{i}^{1}=\mathrm{i}$ or $\mathrm{x}_{i}^{2}=\mathrm{i}$. From Lemma $9, t_{i}$ is the only term accepted by $\left\langle P_{i}^{j}, \mathrm{i}\right\rangle$ where $j$ is 1 or 2 , and from $\mathcal{L}\left(\Delta_{*},\left\langle P_{i}^{1}, \mathrm{x}_{i}^{1}\right\rangle\right) \cap \mathcal{L}\left(\Delta_{*},\left\langle P_{i}^{2}, \mathrm{x}_{i}^{2}\right\rangle\right) \neq \emptyset$, we have $t_{i} \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}^{j}, \mathrm{x}_{i}\right\rangle$ for both $j=1$ and $j=2$.
Thus, we have $f\left(t_{1}, \ldots, t_{n}\right) \xrightarrow[\Delta_{*}]{*} f\left(\left\langle P_{1}^{j}, \mathrm{x}_{1}^{j}\right\rangle, \ldots,\left\langle P_{n}^{j}, \mathrm{x}_{n}^{j}\right\rangle\right) \xrightarrow[\Delta_{*}]{\longrightarrow}\left\langle P_{\mathrm{r}}^{j}, \mathrm{a}\right\rangle$ for both $j=1$ and $j=2$.
Moreover, we have $\sum_{i=1}^{n}\left|P_{i}^{j}\right|+\left|P_{r}^{j}\right|<\sum_{i=1}^{n}\left|P_{i}\right|+\left|P_{\mathrm{r}}\right|$ for both $j=1$ and $j=2$ because if it does not hold, then the rule for $j=1$ or $j=2$ become the same one as the rule $f\left(\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right) \rightarrow\langle P, \mathrm{a}\rangle$. Hence, we have $t \stackrel{*}{\Delta_{*}}\left\langle P_{\mathrm{r}}^{j} \backslash P_{\mathrm{r}}^{\prime \prime}\right\rangle$ for both $j=1$ and $j=2$ from the induction hypothesis.

Proof: We present the proof in the case of $s \underset{\mathcal{R}}{\longrightarrow} t$ because the proof in the case of $s=t$ is trivial and in the case of $s \stackrel{\leftrightarrow}{\mathcal{R}} t^{\prime} \underset{\mathcal{R}}{\hookrightarrow} t$, we can prove it by applying the proof for $s \underset{\mathcal{R}}{\longrightarrow} t$ repeatedly. Let $s \xrightarrow[\Delta_{*}]{*}\langle P$, a $\rangle$ and $s=s[l \sigma]_{p} \overleftrightarrow{\mathcal{R}} s[r \sigma]_{p}=t$ for some rewrite rule $l \rightarrow r \in R$, where $p \in \operatorname{Pos}^{\mu}(s)$. We have a transition sequence $s[l \sigma]_{p} \xrightarrow[\Delta_{*}]{*} s\left[\left\langle P^{\prime}, \mathrm{a}\right\rangle\right]_{p} \xrightarrow[\Delta_{*}]{*}\langle P, \mathrm{a}\rangle$ for some $\left\langle P^{\prime}, \mathrm{a}\right\rangle \in Q_{*}$ by Lemma 10.
From Lemma 14, we have $l \sigma \underset{\Delta_{*}}{*}\langle\{q\}$, a $\rangle$ for all $q \in P$. Therefore, we prove that $r \sigma \underset{\Delta_{*}}{*}\langle\{q\}$, a $\rangle$ for all $q \underset{\in}{\Delta_{*}^{*}} P$, because if we can prove this, we have $s[r \sigma]_{p} \xrightarrow[\Delta_{*}]{*} s\left[\left\langle P^{\prime}, \mathrm{a}\right\rangle\right]_{p} \xrightarrow[\Delta_{*}]{*}\langle P, \mathrm{a}\rangle$ from Lemma 12.
(1) Consider the case where the rewrite rule is of the form $C\left[x_{1}, \ldots, x_{n}\right] \rightarrow$ $g\left(r_{1}, \ldots, r_{m}\right)$ where $C$ has no variable. The diagram of this case is shown in Fig. 2. Here, $C\left[x_{1}, \ldots, x_{n}\right] \sigma \xrightarrow[\Delta_{*}]{*}\langle\{q\}, a\rangle$ is represented in $C\left[x_{1}, \ldots, x_{n}\right] \sigma \underset{\Delta_{*}}{*} C\left[\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right] \underset{\Delta_{*}}{\longrightarrow}\langle\{q\}$, a $\rangle$ for some $\left\langle P_{i}, \mathrm{x}_{i}\right\rangle \in Q_{*}$ for $1 \leq i \leq n$. Since we have $C\left[x_{1}, \ldots, x_{n}\right] \rightarrow g\left(r_{1}, \ldots, r_{m}\right) \in$ $R, C\left[\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right] \underset{\Delta_{*}}{*}\langle\{q\}, \mathrm{a}\rangle$, and $\sigma: X \rightarrow \mathcal{T}(F)$ such that $x_{i} \sigma \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$ for all $1 \leq i \leq n, \Delta_{*}$ has the transition rule $g\left(\left\langle P^{\prime}, \mathrm{x}_{1}^{\prime}\right\rangle, \ldots,\left\langle P_{m}^{\prime}, \mathrm{x}_{m}^{\prime}\right\rangle\right) \rightarrow\langle\{q\}, \mathrm{a}\rangle \in \Delta_{*}$ such that

- $P_{j}^{\prime}= \begin{cases}\left\{q^{r_{j}}\right\} & \cdots \text { if } r_{j} \notin X, \\ P_{i} & \cdots \text { if } r_{j} \in X \wedge \exists i \in I_{j} \cdot \mathbf{x}_{i}=\mathrm{i}, \text { and } \\ \bigcup_{i \in I_{j}} P_{i} & \cdots \text { if } r_{j} \in X \wedge \forall i \in I_{j} \cdot \mathbf{x}_{i}=\mathrm{a} .\end{cases}$
- $\mathrm{x}_{j}^{\prime}=\left\{\begin{array}{l}\left.\mathrm{i} \cdots \text { if } j \notin \mu(g) \wedge\left(r_{j} \in X \Rightarrow \exists i \in I_{j} \cdot \mathrm{x}_{i}=\mathrm{i}\right)\right) \text {, and } \\ \mathrm{a} \cdots \text { otherwise. }\end{array}\right.$
where $I_{j}=\left\{i \mid x_{i}=r_{j}\right\}$.
Here, we show that $r_{j} \sigma \xrightarrow[\Delta_{*}]{*}\left\langle P_{j}^{\prime}, \mathrm{x}_{j}^{\prime}\right\rangle$ for $1 \leq j \leq m$.
(a) For $j$ such that $r_{j} \notin X$, we have $P_{j}^{\prime}=\left\{q^{r_{j}}\right\}$. From the shallowness of $\mathcal{R}$, we have $r_{j} \sigma=r_{j}$. Moreover, we have $r_{j} \stackrel{*}{\Delta} q^{r_{j}}$ from the construction of $\Delta$ and hence we have $r_{j} \xrightarrow[\Delta_{0}]{\stackrel{*}{P}}\left\langle q^{r_{j}}, \mathrm{x}\right\rangle$ for $\mathrm{x} \in\{\mathrm{a}, \mathrm{i}\}$ from Proposition 5 and Proposition 7.
(b) For $j$ such that $r_{j} \in X$ and there exists $i \in I_{j}$ such that $\mathrm{x}_{i}=\mathrm{i}$, we have $r_{j} \sigma=x_{i} \sigma$ and hence $r_{j} \sigma \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}, \mathrm{i}\right\rangle$. If $j \notin \mu(g)$, we have $\mathrm{x}_{i}^{\prime}=\mathrm{i}$ and hence $r_{j} \sigma \xrightarrow[\Delta_{*}]{*}\left\langle P_{j}^{\prime}, \mathrm{x}_{i}^{\prime}\right\rangle=\left\langle P_{i}, \mathrm{i}\right\rangle$. (c) For $j$ such that $r_{j} \in X$ and there exists no $i \in I_{j}$ such that $\mathbf{x}_{i}=\mathbf{i}$,

\text { since we have } r_{j} \sigma=x_{i^{\prime}} \sigma \xrightarrow[\Delta_{k}]{*}\left\langle P_{i^{\prime}}, \mathrm{x}_{i^{\prime}}\right\rangle=\left\langle P_{i^{\prime}}, \text { a }\right\rangle \text { for all } i^{\prime} \in I_{j}
$$ $r_{j} \sigma \xrightarrow[\Delta_{*}]{*}\left\langle P_{j}^{\prime}, \mathrm{x}_{j}^{\prime}\right\rangle=\left\langle\bigcup_{i^{\prime} \in I_{j}} P_{i^{\prime}}, \mathrm{a}\right\rangle$ follows from Lemma 12.

Therefore we have $g\left(r_{1}, \ldots, r_{m}\right) \sigma \underset{\Delta_{*}}{*} g\left(\left\langle P_{1}^{\prime}, \mathrm{x}_{1}^{\prime}\right\rangle, \ldots,\left\langle P_{m}^{\prime}, \mathrm{x}_{m}^{\prime}\right\rangle\right) \xrightarrow[\Delta_{*}]{\longrightarrow}$ $\langle\{q\}, \mathrm{a}\rangle$.
By applying the above statement for all $q \in P$, this lemma holds.
(2) In the case where the rewrite rule is of the form $C\left[x_{1}, \ldots, x_{n}\right] \rightarrow x_{i}$, we can prove this lemma similarly to the previous case.

The following lemma shows completeness of $\mathrm{P}_{\mathrm{cs}}$.
Lemma 16 If $\mathcal{R}$ is right-shallow CS-TRS, then $\mathcal{L}\left(\mathcal{A}_{*}\right) \supseteq \underset{\mathcal{R}}{\longrightarrow}[\mathcal{L}(\mathcal{A})]$.
Proof: Let $s \stackrel{*}{\mathcal{R}} t$ and $s \underset{\Delta}{*} q \in Q^{f}$. Since we have $s \xrightarrow[\Delta_{0}]{*}\langle\{q\}, i\rangle$ from Proposition 5, we also have $s \xrightarrow[\Delta_{0}]{*}\langle\{q\}$, a from Proposition 7. Hence $t \xrightarrow[\Delta_{*}]{*}$ $\langle\{q\}, \mathrm{a}\rangle \in Q_{*}^{f}$ follows by Lemma 15 .
To prove the soundness of $\mathrm{P}_{\mathrm{csin}}$, we define the following measures of transition and order. These are necessary to prove soundness of $\mathrm{P}_{\mathrm{cs}}$.

Definition 17 Let $\|t \xrightarrow[\Delta_{*}^{*}]{*} P\|$ be the sequence of integers defined as follows ${ }^{\star 1}$ :

Note that $\sqsupset$ is well-founded, $\alpha \sqsupset \beta$ implies $\alpha \sqsupseteq \beta$, and if $\alpha \sqsupseteq \beta$ then $\beta \not \neg \alpha$. The minimal components in the order $\sqsupset$ are the transitions of the form $a \underset{\Delta_{0}}{\longrightarrow}\langle P, \mathrm{x}\rangle$ where $a$ is a constant.

The following lemma is a key lemma for soundness of $\mathrm{P}_{\mathrm{cs}}$.

Lemma 19 Let $\mathcal{R}$ be a right-linear right-shallow CS-TRS. Then, $\alpha: t \xrightarrow[\Delta_{*}]{*}$ $\langle P, \mathrm{a}\rangle$ implies that there exists $s$ and $q \in P$ such that $s \underset{\mathcal{R}}{\stackrel{*}{\longrightarrow}} t$ and $s \underset{\Delta_{0}}{*}\langle\{q\}, \mathrm{a}\rangle$.

Proof: We show this lemma by induction on $\alpha$ with respect to $\sqsupset$. Since we have $t \xrightarrow[\Delta_{*}]{*}\langle\{q\}$, a $\rangle$ for all $q \in P$ from Lemma 14, we show the proof in the case where $P$ is of the form $\{q\}$.
(1) Consider the case where $\alpha$ is represented as $t=g\left(t_{1}, \ldots, t_{m}\right) \xrightarrow[\Delta_{*}]{*}$ $g\left(\left\langle P_{1}^{\prime}, \mathrm{x}_{1}^{\prime}\right\rangle, \ldots,\left\langle P_{m}^{\prime}, \mathrm{x}_{m}^{\prime}\right\rangle\right) \xrightarrow[\Delta_{k} \backslash \Delta_{k-1}]{ }\langle\{q\}, \mathrm{a}\rangle$.
(a) If $k=0$, the transition rule $g\left(\left\langle P_{1}^{\prime}, \mathrm{a}\right\rangle, \ldots,\left\langle P_{m}^{\prime}, \mathrm{a}\right\rangle\right) \rightarrow\langle\{q\}, \mathrm{a}\rangle$ is produced at Step 1, and hence each $P_{j}^{\prime}$ is of the form $\left\{q_{j}\right\}$ and we have $j \in \mu(g)$ iff $\mathrm{x}_{j}^{\prime}=\mathrm{a}$. For $j \in \mu(g)$, we have $\mathrm{x}_{j}^{\prime}=\mathrm{a}$ and hence there exists $s_{j}$ such that $s_{j} \underset{\mathcal{R}}{\stackrel{*}{\longrightarrow}} t_{j}$ and $s_{j} \xrightarrow[\Delta_{0}]{*}\left\langle P_{j}^{\prime}, \mathrm{a}\right\rangle=\left\langle\left\{q_{j}\right\}, \mathrm{a}\right\rangle$ from the induction hypothesis. For $j \notin \mu(g)$, we have $\mathrm{x}_{j}^{\prime}=\mathrm{i}$ and $t_{j} \xrightarrow[\Delta_{0}]{*}\left\langle P_{j}^{\prime}\right.$, i $\rangle$ from Proposition 6. We take $s_{j}=t_{j}$ for $j \notin \mu(g)$. Finally, we obtain $g\left(s_{1}, \ldots, s_{m}\right) \xrightarrow[\mathcal{R}]{*} g\left(t_{1}, \ldots, t_{m}\right)=t$ and

Thus, this lemma holds in the case $k=0$.

The diagram of this case is shown in Fig. 3. From the production of the transition rule, we have $C\left[x_{1}, \ldots, x_{n}\right] \rightarrow g\left(r_{1}, \ldots, r_{m}\right) \in R$ where $C$ has no variable and $C\left[\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right] \stackrel{*}{\Delta_{k-1}}\left\langle\{q\}\right.$, à , and $\sigma^{\prime}: X \rightarrow \mathcal{T}(F)$ such that $x_{i} \sigma^{\prime} \xrightarrow{*} \xrightarrow{\Delta_{k-1}}\left\langle P_{i}, \mathbf{x}_{i}\right\rangle$ for all $1 \leq i \leq n$, and each $\left\langle P_{j}^{\prime}, \mathrm{x}_{j}^{\prime}\right\rangle$ is represented as follows:


- $\mathrm{x}_{j}^{\prime}=\left\{\begin{array}{l}\left.\mathrm{i} \cdots \text { if } j \notin \mu(g) \wedge\left(r_{j} \in X \Rightarrow \exists i \in I_{j} . \mathrm{x}_{i}=\mathrm{i}\right)\right) \text {, and } \\ \mathrm{a} \cdots \text { otherwise. }\end{array}\right.$
where $I_{j}=\left\{i \mid x_{i}=r_{j}\right\}$. In the following, we show that there exists the substitution $\sigma$ such that $g\left(r_{1}, \ldots, r_{m}\right) \sigma \stackrel{*}{\mathcal{R}} g\left(t_{1}, \ldots, t_{m}\right)$ and $\alpha^{\prime}: g\left(r_{1}, \ldots, r_{m}\right) \sigma \underset{\Delta_{*}}{*} g\left(\left\langle P_{1}^{\prime}, \mathbf{x}_{1}^{\prime}\right\rangle, \ldots,\left\langle P_{m}^{\prime}, \mathrm{x}_{m}^{\prime}\right\rangle\right) \xrightarrow[\Delta_{k} \backslash \Delta_{k-1}]{ }\langle\{q\}, \mathrm{a}\rangle$ where $\alpha^{\prime} \sqsubseteq \alpha$.
(i) For $j \notin \mu(g)$ such that $r_{j} \notin X$, we have $P_{j}^{\prime}=\left\{q^{r_{j}}\right\}$ and $\mathrm{x}_{j}^{\prime}=\mathrm{i}$. Since $t_{j} \xrightarrow[\Delta_{0}]{*}\left\langle\left\{q^{r_{j}}\right\}, \mathrm{i}\right\rangle$ is from Proposition 7 , we have $t_{j}=r_{j}$ from Proposition 5 and the construction of $\mathcal{A}$.
(ii) For $j \in \mu(g)$ such that $r_{j} \notin X$, we have $P_{j}^{\prime}=\left\{q^{r_{j}}\right\}$ and $\mathrm{x}_{j}^{\prime}=\mathrm{a}$. (iii) For $j$ such that $r_{j} \in X, j \notin \mu(g)$, and there exists $i \in I_{j}$ such that $\mathbf{x}_{i}=\mathrm{i}$, we have $t_{j} \xrightarrow[\Delta *]{*}\left\langle P_{j}^{\prime}, \mathrm{x}_{j}^{\prime}\right\rangle=\left\langle P_{i}, \mathrm{i}\right\rangle$. (iv) For ${ }_{j}$ such that $r_{j} \in X, j \in \mu(g)$, and there exists $i \in I_{j}$ such that $\mathbf{x}_{i}=\mathbf{i}$, we have $t_{j} \xrightarrow[\Delta_{*}]{*}\left\langle P_{j}^{\prime}, \mathbf{x}_{j}^{\prime}\right\rangle=\left\langle P_{i}, \mathrm{a}\right\rangle$. Since we have $\left\langle P_{i}, \mathrm{i}\right\rangle=\left\langle P_{i}, \mathbf{x}_{i}\right\rangle$ where $P_{i}$ is of the form $\left\{q_{i}\right\}$ from

Proposition 6, there exists a $s_{j}$ such that $s_{j} \underset{\mathcal{R}}{\stackrel{*}{\mathcal{R}}} t_{j}$ and $s_{j} \xrightarrow[\Delta_{0}]{*}$ $\left\langle P_{j}^{\prime}, \mathrm{x}_{j}^{\prime}\right\rangle$ from the induction hypothesis. Let $s_{j}$ be $r_{j} \sigma$.
(v) For $j$ such that $r_{j} \in X$ and there exists no $i \in I_{j}$ such that $\mathrm{x}_{i}=\mathrm{i}$, we take $r_{j} \sigma=t_{j}$.

(i) For $i$ such that there exists ${ }_{j}$ such that $x_{i}=r_{j}$ and $i^{\prime} \in I_{j}$ such that $\mathrm{x}_{i^{\prime}}=\mathrm{i}$, we have $x_{i^{\prime}} \sigma^{\prime} \xrightarrow{*}\left\langle P_{i^{\prime}}, \mathbf{i}\right\rangle=\left\langle P_{j}^{\prime}, \mathbf{i}\right\rangle$ from Proposition 5. Thus we have $x_{i} \sigma^{\prime} \stackrel{\Delta_{0}}{=} x_{i} \sigma^{\prime \prime}$ from Lemma 9 and hence $x_{i} \sigma^{\prime \prime} \xrightarrow[\Delta_{k-1}]{*}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$.
(ii) For $i$ such that there exists $j$ such that $x_{i}=r_{j}$ and no $i^{\prime} \in I_{j}$ such that $\mathrm{x}_{i^{\prime}}=\mathrm{i}$, we have $P_{i} \subseteq P_{j}^{\prime}$ and hence $x_{i} \sigma^{\prime \prime} \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$ from Lemma 12.
(iii) For $i$ such that there exists no $j$ such that $x_{i}=r_{j}$, we have $x_{i} \sigma^{\prime \prime}=x_{i} \sigma^{\prime} \xrightarrow[\Delta_{k-1}]{*}\left\langle P_{i}, \mathrm{x}_{i}\right\rangle$ from the construction of the rule.
Thus, we have $\beta: C\left[x_{1}, \ldots, x_{n}\right] \sigma^{\prime \prime} \xrightarrow[\Delta_{*}]{\Delta_{k-1}} C\left[\left\langle P_{1}, \mathrm{x}_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}\right\rangle\right] \underset{\Delta_{k-1}}{*}$ $\langle\{q\}, \mathrm{a}\rangle$.
Note that $\beta \sqsubset \alpha^{\prime}$ because transition rules in $\Delta_{k} \backslash \Delta_{k-1}$ are not applied at $\beta$ except for the transitions $x_{i} \sigma^{\prime \prime} \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}, \mathbf{x}_{i}\right\rangle$ where there exists $j$ such that $x_{i}=r_{j}$. However, since $x_{i} \sigma^{\prime \prime}$ is a proper subterm of $g\left(r_{1}, \ldots, r_{m}\right) \sigma^{\prime \prime}, \alpha^{\prime}$ does not occur in $\beta$.
Finally, we have the term $s$ such that $s \stackrel{*}{\mathcal{R}} C\left[x_{1}, \ldots, x_{n}\right] \sigma^{\prime \prime} \underset{\mathcal{R}}{*} t$ and $s \xrightarrow[\Delta_{0}]{*}\langle\{q\}$, a from the induction hypothesis.
(2) If the last transition rule is of the form $\left\langle P^{\prime}, \mathrm{a}\right\rangle \rightarrow\langle P, \mathrm{a}\rangle$, this lemma holds similarly to the previous case.
The following lemma shows soundness of $\mathrm{P}_{\mathrm{cs}}$.

Lemma 20 If $\mathcal{R}$ be right-linear and right-shallow, then $\mathcal{L}\left(\mathcal{A}_{*}\right) \subseteq \underset{\mathcal{R}}{\leftrightarrows}[\mathcal{L}(\mathcal{A})]$.
Proof: Let $t$ be $t \xrightarrow[\Delta_{*}]{*}\langle P, \mathrm{x}\rangle \in Q_{*}^{f}$ where $P$ contains the state $q^{f} \in Q^{f}$. Then, we have $t \underset{\Delta_{*}}{*}\left\langle\left\{q^{f}\right\}, \mathrm{x}\right\rangle$ from Lemma 14. If $\mathrm{x}=\mathrm{i}$, we have $t \xrightarrow[\Delta_{0}]{*}\left\langle\left\{q^{f}\right\}, \mathrm{i}\right\rangle \in Q_{*}^{f}$ from Proposition 6. If $\mathrm{x}=\mathrm{a}$, there exists the term $s$ such that $s \underset{\mathcal{R}}{*} t$ and $s \xrightarrow[\Delta_{0}]{*}\left\langle\left\{q^{f}\right\}\right.$, a $\rangle$ from Lemma 19 and we have $s \xrightarrow[\Delta_{0}]{*}\left\langle\left\{q^{f}\right\}\right.$, i $\rangle$ from Proposition 7 .
Thus, we have $s \stackrel{*}{\Delta} q^{f}$ from Proposition 5 .
The following theorem is proved by Lemma 16 and 20.
Theorem 21 For any right-linear right-shallow CS-TRS $\mathcal{R}$, we can construct a TA recognizing the set of terms that is reachable from a term. Thus, contextsensitive reachability is decidable for right-linear right-shallow TRSs.

## 4. Decidability of Innermost Reachability for Shallow CS-TRSs

In this section, we show that innermost reachability for shallow CS-TRSs is decidable. Similarly to the previous section, we show the algorithm $\mathrm{P}_{\text {csin }}$ that constructs the tree automaton accepting the set of terms reachable by innermost reduction of a shallow CS-TRS from an input term. The algorithm $\mathrm{P}_{\text {csin }}$ is a modification of the algorithm $\mathrm{P}_{\mathrm{cs}}$ by the idea in Ref. 11). States of output automata obtained by $\mathrm{P}_{\mathrm{csin}}$ have three components, while the one by $\mathrm{P}_{\mathrm{cs}}$ has two components. Since we must check whether each proper subterm of redex is a context-sensitive normal form or not in the innermost case, we augment
the parameter that shows whether the state accepts the context-sensitive normal form or not. Therefore, first we show the construction of a deterministic complete reduced tree automata accepting the set of context-sensitive normal forms, and then we show $\mathrm{P}_{\text {csin }}$.

### 4.1 Tree Automata Accepting Context-sensitive Normal Forms

In this subsection, we give an algorithm to construct a deterministic complete reduced tree automata recognizing the set of context-sensitive normal forms for shallow CS-TRS $\mathcal{R}$. However, in general, ordinary tree automata cannot recognize the set of context-normal forms for shallow CS-TRS. Therefore we use tree automata with constraints between brothers (TACBB) ${ }^{3)}$.
The procedure is similar to the ones for TRSs ${ }^{3)}$. The steps of the algorithm to construct TACBB $\mathcal{A}_{\mathrm{NF}}$ are as follows:
(1) Construct the $\mathrm{TACBB} \mathcal{A}_{l}$ that recognizes the set of terms having a redex $l \sigma$ at a $\mu$-replacing position for each $l \rightarrow r \in R$ and determinize it.
(2) Construct the union of all $\mathcal{A}_{l}$ 's and convert the TA into complete and reduced TA $\mathcal{A}$
(3) We output a TA recognizing the complement of $\mathcal{L}(\mathcal{A})$ as $\mathcal{A}_{\mathrm{NF}}$.

The steps (2) and (3) are obviously possible from Theorem 1. Now we show the details of step (1).
Each component of $\mathcal{A}_{l}$ is as follows.

- $Q_{l}=\left\{u^{\circ}, u_{\perp}\right\} \cup\left\{u_{t} \mid t \triangleleft l, t \notin X\right\}$.
- $Q_{l}^{f}=\left\{u^{\circ}\right\}$
- $\Delta_{l}$ consists of the following transition rules:
(i) $f\left(u_{\perp}, \ldots, u_{\perp}\right) \xrightarrow{\top} u_{\perp}$ for each $f \in F$,
(ii) $f\left(u_{t_{1}}, \ldots, u_{t_{n}}\right) \xrightarrow{\top} u_{f\left(t_{1}, \ldots, t_{n}\right)}$ for each $f \in F$ and state $u_{f\left(t_{1}, \ldots, t_{n}\right)}$.
(iii) $f\left(u_{s_{1}}, \ldots, u_{s_{n}}\right) \xrightarrow{c} u^{\circ}$ where $f\left(s_{1}, \ldots, s_{n}\right)$ is the term obtained by replacing all variables in $l=f\left(l_{1}, \ldots, l_{n}\right)$ by $\perp$, and $c$ is the conjunction of all equalities $i=j$ where $l_{i}=l_{j} \in X$.
(iv) $f\left(u_{1}, \ldots, u_{n}\right) \rightarrow u^{\circ}$ for each $f \in F$ if exactly one $u_{j}$ such that $j \in \mu(f)$ is $u^{\circ}$ and the other $u_{i}$ 's are $u_{\perp}$.
Each state $u_{t}$ is associated with a proper non-variable subterm $t$ of $l$. From the shallowness of $R, t$ in $u_{t}$ has no variable.
We obtain the following lemmas for $\mathcal{A}_{l}$.

Lemma $22 \mathcal{L}\left(\mathcal{A}_{l}, u_{t}\right)$ is equal to the singleton set that consists of $t \triangleleft l$, (that is, $\left.\mathcal{L}\left(\mathcal{A}_{l}, u_{t}\right)=\{t \in \mathcal{T}(F)\}.\right)$

Proof:
$(\supseteq)$ By induction on the height $|t|$ of $t$, we prove the claim that $t \xrightarrow[\Delta_{l}]{*} u_{t}$ for the proper non-variable subterm $t$ of $l$. We can represent $t$ as $f\left(t_{1}, \ldots, t_{n}\right)$ where $n \geq 0$. From the construction of (ii) of $\Delta_{l}$, we have the transition rule $f\left(u_{t_{1}}, \ldots, u_{t_{n}}\right) \xrightarrow{\top} u_{f\left(t_{1}, \ldots, t_{n}\right)}$
From the induction hypothesis, we have $t_{i} \xrightarrow[\Delta]{*} u_{t_{i}}$ for all $1 \leq i \leq n$. Thus, we have $t \sigma=f\left(t_{1}, \ldots, t_{n}\right) \sigma \xrightarrow[\Delta_{l}]{*} f\left(u_{t_{1}}, \ldots, u_{t_{n}}\right) \xrightarrow[\Delta_{l}]{\Delta_{l}} u_{t}$.
$(\subseteq)$ We show that if $\alpha: t \underset{\Delta_{l}}{*} u_{f\left(t_{1}, \ldots, t_{n}\right)}$ then we have $t=f\left(t_{1}, \ldots, t_{n}\right)$ by induction on $|\alpha|$. From the construction of $\Delta_{l}$, the last transition rule applied in $\alpha$ is represented as $f\left(u_{t_{1}}, \ldots, u_{t_{n}}\right) \xrightarrow{c} u_{f\left(t_{1}, \ldots, t_{n}\right)}$.
From the induction hypothesis, we have $t_{i} \xrightarrow[\Delta_{l}]{*} u_{t_{i}}$, for all $1 \leq i \leq n$.
Thus, we have $f\left(t_{1}, \ldots, t_{n}\right)=f\left(l_{1}, \ldots, l_{n}\right) \sigma$.
Lemma $23 \mathcal{L}\left(\mathcal{A}_{l}\right)=\left\{t[s]_{p} \mid t \in \mathcal{T}(F), s\right.$ is a ground instance of $\left.l, p \in \operatorname{Pos}^{\mu}(t)\right\}$.
Proof:
$(\supseteq)$ Let $l=f\left(l_{1}, \ldots, l_{n}\right)$. First, we show that $s=f\left(l_{1}, \ldots, l_{n}\right) \sigma \xrightarrow[\Delta_{l}]{*} u^{\circ}$. For $l_{i} \notin X, l_{i}$ is ground from shallowness of $l$ and $l_{i} \xrightarrow[\Delta_{l}]{*} u_{l_{i}}$. For $l_{i} \in X$, we have $l_{i} \sigma \xrightarrow[\Delta_{l}]{*} u_{\perp}$. From (iii) of construction of $\Delta_{l}$, we have the transition rule $f\left(u_{s_{1}}, \ldots, u_{s_{n}}\right) \xrightarrow{c} u^{\circ}$ where $s_{i}=l_{i}$ for $i \notin X$ and $s_{i}=\perp$ for $i \in X$, and $c$ is the conjunction of all equalities $i=j$ where $l_{i}=l_{j} \in X$. Since we have $l_{i} \sigma=l_{j} \sigma$ for $l_{i}=l_{j} \in X, s$ satisfies $c$. Thus, we have $s \stackrel{*}{\Delta_{l}} u^{\circ}$ and from (i) and (iv) of construction of $\Delta_{l}$, we have $t[s]_{p} \xrightarrow[\Delta_{l}]{*} t\left[u^{\circ}\right]_{p} \xrightarrow[\Delta_{l}]{\xrightarrow[\Delta_{l}]{ }} u^{\circ}$.
$(\subseteq)$ Let $l=f\left(l_{1}, \ldots, l_{n}\right)$ and $t \xrightarrow[\Delta_{l}]{*} \quad u^{\circ}$, then we have $t \xrightarrow[\Delta_{l}]{*}$ $t\left[f\left(u_{s_{1}}, \ldots, u_{s_{n}}\right)\right]_{p} \xrightarrow[\Delta_{l}]{\longrightarrow} t\left[u^{\circ}\right]_{p} \xrightarrow[\Delta_{l}]{*} u^{\circ} \stackrel{\Delta_{l}}{\text { where }} s_{i}=l_{i}$ for $l_{i} \notin X, s_{i}=\stackrel{\Delta_{l}}{\perp}$ for $l_{i} \in X$, and $p \in \operatorname{Pos}^{\mu}(t)$ from (iii) and (iv) of the construction of $\Delta_{l}$. From Lemma 22, we have $\left.t\right|_{p i}=l_{i} \notin X$. Moreover, since the transition $t\left[f\left(u_{s_{1}}, \ldots, u_{s_{n}}\right)\right]_{p} \xrightarrow[\Delta_{l}]{ } t\left[u^{\circ}\right]_{p}$ has the constraint $c$ that is the conjunction of all equalities $i=j$ where $l_{i}=l_{j} \in X$, we have $\left.t\right|_{p i}=\left.t\right|_{p j}$ for $l_{i}=l_{j} \in X$. Hence $\left.t\right|_{p}$ is a ground substitution of $l$. Thus we have $t=t[s]_{p}$ for some ground instance $s$ of $l$.

The method of determinization is the so called "subset construction." The claim " $t \xrightarrow[\mathcal{A}^{d}]{*} S$ iff $S=\{q \mid t \xrightarrow[\mathcal{A}]{*} q\}$ " holds where $\mathcal{A}^{d}$ is determinized from $\mathcal{A}$ by subset construction.

Therefore, the following lemma holds.
Lemma 24 Let $s$ be a proper subterm of $l, u_{s}$ and $S^{\prime \prime}$ be a state and a subset of the set of states of TACBB $\mathcal{A}_{l}$ respectively, and $\mathcal{A}_{l}^{d}$ be a determinized TACBB from $\mathcal{A}_{l}$ by subset construction. Then, $t \underset{\mathcal{A}_{l}^{d}}{*}\left\{u_{s}\right\} \cup S^{\prime}$ iff $t=s$.
Proof: From Lemma 22 and shallowness of $l, t \underset{\mathcal{A}_{l}}{\stackrel{*}{\longrightarrow}} q_{s}$ iff $t=s$.
Thus, this lemma holds from the above claim.
As shown in Lemma 23, the TACBB $\mathcal{A}_{l}$ recognizes the set of terms having a redex $l \sigma$ at a $\mu$-replacing position. Now we obtain the following lemma.

Lemma 25 For a CS-TRS $\mathcal{R}$, we can construct a deterministic complete reduced $\mathrm{TACBB} \mathcal{A}_{\mathrm{NF}}$ that recognizes CS-NF $\mathcal{R}$.

Proof: By step (1) of the algorithm, we obtain a TACBB $\mathcal{A}_{l}$ for each $l \rightarrow r \in R$, and we can determinize them. Let the determinized TACBB from $A_{l}$ be $A_{l}^{d}=$ $\left\langle Q_{l}^{d}, Q_{l}^{d f}, \Delta_{l}^{d}\right\rangle$.

We can obtain a TACBB $\mathcal{A}^{\prime}=\left\langle F, Q^{\prime}, Q^{\prime f}, \Delta^{\prime}\right\rangle$ that recognizes the following set:

Let $R=\left\{l_{i} \rightarrow r_{i} \mid 1 \leq i \leq m\right\}$. The concrete construction of the TACBB $\mathcal{A}^{\prime}=\left\langle Q^{\prime}, Q^{\prime f}, \Delta^{\prime}\right\rangle$ is as follows:

- $f\left(\left\langle u_{11}, \ldots, u_{1 m}\right\rangle, \ldots,\left\langle u_{n 1}, \ldots, u_{n m}\right\rangle\right) \xrightarrow{c} \quad\left\langle u_{1}, \ldots, u_{m}\right\rangle \quad \in \quad \Delta^{\prime} \quad$ where $f\left(u_{1 i}, \ldots, u_{m i}\right) \xrightarrow{c_{i}} u_{i} \in \Delta_{l_{i}}^{d}$ and $c=c_{1} \wedge \cdots \wedge c_{m}$.
This is the construction of the union of all $\mathcal{A}_{l}^{\prime}$ 's. Since this construction preserves determinacy of TACBB, the constructed TACBB $\mathcal{A}^{\prime}$ is deterministic.

Converting $\mathcal{A}^{\prime}$ to complete one is not so difficult. By adding the new state
$q_{\mathrm{e}}$ and new transition rules such that $f\left(q_{1}, \ldots, q_{n}\right) \xrightarrow{c} q_{\mathrm{e}}$ where $q_{1}, \ldots, q_{n} \in Q^{\prime}$ and $c=\mathrm{T}$ if $f\left(q_{1}, \ldots, q_{n}\right)$, which does not occur in any transition rule of $\Delta^{\prime}$, otherwise $c$ is equivalent to $\neg\left(c_{1} \vee \cdots \vee c_{k}\right)$ where $f\left(q_{1}, \ldots, q_{n}\right) \xrightarrow{c_{j}} q \in \Delta^{\prime}$ for some $q \in Q^{\prime}$.
Since the emptiness problem of TACBB is decidable from Theorem 1, we can check whether each state is accessible or not and hence we can construct a reduced TACBB $A^{\prime \prime}$ by erasing the inaccessible state of $\mathcal{A}^{\prime}$.
Finally, since $\mathcal{A}^{\prime \prime}$ is deterministic and complete, we can easily obtain the TA $\mathcal{A}^{\prime \prime \prime}$ that accepts complementation of $\mathcal{A}^{\prime \prime}$ by replacing the final state.
From Lemma $23, \mathcal{L}\left(\mathcal{A}^{\prime \prime}\right)$ is the set of terms having redex at a $\mu$-replacing position. Thus we can obtain the deterministic, complete, and reduced TACBB $\mathcal{A}_{\mathrm{NF}}$ recognizing CS-NF $\mathcal{R}_{\mathcal{R}}$ by the algorithm.
We show an example of $\mathcal{A}_{\mathrm{NF}}$ in Appendix A.1.1.
For the constructed TA $\mathcal{A}_{\mathrm{NF}}$, the following proposition holds from Lemmas 24 and 25 .

Proposition 26 Let $t \in \mathcal{T}(F), u \in Q_{\mathrm{NF}}$, and $t \xrightarrow[\Delta_{\mathrm{NF}}]{*} u$. If $t$ is a proper subterm of some $l$ of $l \rightarrow r \in R$ where $\mathcal{R}=(R, \mu)$ is a shallow CS-TRS, then $u$ accepts no term other than $t$.

Proof: Let $\mathcal{A}_{l}^{d}$ be the deterministic TACBB obtained in step (1) of the algorithm. From Lemma 22, Lemma 24, and shallowness of $R$, we have $t \stackrel{*}{\Delta_{l}} S \in Q_{l}^{d}$ where $S$ contains $u_{t} \in Q_{l}$ and there exists no term other than $t$ accepted by $u_{t}$. Thus, from the construction of $\Delta_{\mathrm{NF}}$, there exists no term accepted by $u$ other than $t$.

Proposition 27 If $f\left(u_{1}, \ldots, u_{n}\right) \xrightarrow{c} u \in \Delta_{\mathrm{NF}}$ and $u \in Q_{\mathrm{NF}}^{f}$, then $i \in \mu(f)$ implies $u_{i} \in Q_{\mathrm{NF}}^{f}$.

Proof: Let $f\left(u_{1}, \ldots, u_{n}\right) \xrightarrow{c} u \in \Delta_{\mathrm{NF}}, u \in Q_{\mathrm{NF}}^{f}$, and assume $u_{i} \notin Q_{\mathrm{NF}}^{f}$ for some $i \in \mu(f)$. Since $\mathcal{A}_{\mathrm{NF}}$ is a reduced TACBB from Lemma 25 , there exists ground terms $t_{1}, \ldots, t_{n}$ such that $t_{j} \xrightarrow[\Delta_{\mathrm{NF}}]{*} u_{j}$ for each $j(1 \leq j \leq n)$. Hence we have $f\left(t_{1}, \ldots, t_{n}\right) \xrightarrow[\Delta_{\mathrm{NF}}]{*} f\left(u_{1}, \ldots, u_{n}\right) \xrightarrow[\Delta_{\mathrm{NF}}]{\Delta_{\mathrm{NF}}} u$.

Here $f\left(t_{1}, \ldots, t_{n}\right) \in \mathrm{CS}_{-} \mathrm{NF}_{\mathcal{R}}$ and $t_{i} \notin \mathrm{CS}_{-} \mathrm{NF}_{\mathcal{R}}$ is from Lemma 25. Since $t_{i}$ is

not a context-sensitive normal form and $i \in \mu(f)$, the term $f\left(t_{1}, \ldots, t_{n}\right)$ is not a context-sensitive normal form, which contradicts $f\left(t_{1}, \ldots, t_{n}\right) \in \mathrm{CS}^{\prime} \mathrm{NF}_{\mathcal{R}}$.

### 4.2 An Algorithm to Construct the Set of Reachable Terms by Context-Sensitive Innermost Reduction

In this section, we show the concrete definition of $\mathrm{P}_{\text {csin }}$ to construct a TACBB that recognizes the set of reachable terms by innermost reduction of a shallow CS-TRS. $\mathrm{P}_{\text {csin }}$ is a modification of $\mathrm{P}_{\mathrm{cs}}$. The main difference between $\mathrm{P}_{\mathrm{csin}}$ and $\mathrm{P}_{\mathrm{cs}}$ is the number of components of each state of output automata. States of output TA by $\mathrm{P}_{\text {csin }}$ have an extra component that is a state of $\mathcal{A}_{\mathrm{NF}}$. Since $\mathcal{A}_{\mathrm{NF}}$ is TACBB, output automata by $\mathrm{P}_{\text {csin }}$ are also TACBB.

## Algorithm $\mathbf{P}_{\text {csin }}$ :

Input A term $t$ and a shallow CS-TRS $\mathcal{R}=(R, \mu)$ that has no erasing variable.
Output A TA $\mathcal{A}_{*}=\left\langle Q_{*}, Q_{*}^{f}, \Delta_{*}\right\rangle$ such that $\mathcal{L}\left(\mathcal{A}_{*}\right)=\underset{\mathcal{R}}{\longrightarrow}[\mathcal{L}(\mathcal{A})]$.
Step 1 (initialize) (1) Prepare a TACBB $\mathcal{A}_{\mathrm{NF}}$ obtained by the algorithm in previous section and a TA $\mathcal{A}=\left\langle Q, Q^{f}, \Delta\right\rangle$ where each state $q^{s}$ accepts $s \in\{t\} \cup \operatorname{RS}(R), \operatorname{RS}(R)$ is the set of the proper ground subterm of the right-hand sides of $R$. Here we assume $Q=\left\{q^{s} \mid s \unlhd s^{\prime}, s^{\prime} \in\{t\} \cup \operatorname{RS}(R)\right\}$, $Q^{f}=\left\{q^{t}\right\}$, and $\mathcal{L}\left(\mathcal{A}_{\mathrm{RS}}, q^{s}\right)=\{s\}$ for all $q^{s}$.
(2) Let

- $k:=0$,
- $Q_{*}=\{P(\subseteq Q)\} \times\{\mathrm{a}\} \times Q_{\mathrm{NF}} \cup\{\{q\} \mid q \in Q\} \times\{\mathrm{a}\} \times Q_{\mathrm{NF}}$,
- $Q_{*}^{f}=\left\{P(\subseteq Q) \mid P \cap Q^{f} \neq \emptyset\right\} \times\{\mathrm{a}\} \times Q_{\mathrm{NF}}$, and

(2) $\left\langle P_{1}^{\prime} \cup P_{2}^{\prime}, \mathrm{a}, u\right\rangle \xrightarrow{\mathrm{T}}\left\langle P_{1} \cup P_{2}, \mathrm{a}, u\right\rangle \in \Delta_{k+1}$ if $\left\langle P_{1}^{\prime}, \mathrm{a}, u\right\rangle \xrightarrow{\mathrm{T}}\left\langle P_{1}, \mathrm{a}, u\right\rangle \in \Delta_{k}$, and, $\left\langle P_{2}^{\prime}\right.$, a,$\left.u\right\rangle \xrightarrow{\mathrm{T}}\left\langle P_{2}\right.$, a,$\left.u\right\rangle \in \Delta_{k}$ or $P_{2}^{\prime}=P_{2}$.
Step 4 If $\Delta_{k+1}=\Delta_{k}$ then stop and set $\Delta_{*}=\Delta_{k}$. Otherwise, $k:=k+1$, and go to Step 2.
We show an example that shows how $\mathrm{P}_{\mathrm{csin}}$ works in Appendix A.1.2. This procedure $\mathrm{P}_{\text {csin }}$ eventually terminates at some $k$ and apparently $\Delta_{0} \subset \cdots \subset$ $\Delta_{k}=\Delta_{k+1}=\cdots$ similarly to $\mathrm{P}_{\mathrm{cs}}$.
In the following, we show the correctness of $\mathrm{P}_{\text {csin }}$.

[^3]First, we show several propositions. Since Propositions 28-31 below are similar to the case of $\mathrm{P}_{\mathrm{cs}}$, we abbreviate their proofs.

Proposition 28 Let $s \in \mathcal{T}(F)$, Then $s \xrightarrow[\Delta]{*} q^{s} \in Q$ iff $s \xrightarrow[\Delta_{0}]{*}\left\langle\left\{q^{s}\right\}, \mathbf{i}, u\right\rangle$ for some $u \in Q_{\mathrm{NF}}$.

Proposition 29 Let $t \in \mathcal{T}(F)$. For any $k$, if $t \underset{\Delta_{k}}{*}\langle P, i, u\rangle$, then $t \xrightarrow[\Delta_{0}]{*}\langle P, \mathbf{i}, u\rangle$. Moreover, $P$ is of the form $\{q\}$.

Proposition 30 Let $t \in \mathcal{T}(F)$. Then, for any $k, t \xrightarrow[\Delta_{0}]{*}\langle P, \mathrm{a}, u\rangle$ iff $t \xrightarrow[\Delta_{0}]{*}$ $\langle P$, i, $u\rangle$.

Proposition 31 Let $t \in \mathcal{T}(F)$. Then, $t \underset{\Delta_{k}}{*}\langle P, \mathrm{i}, u\rangle$ implies $t \xrightarrow[\Delta_{k}]{*}\langle P, \mathrm{a}, u\rangle$.
Proposition 32 If the rule $f\left(\left\langle P_{1}, \mathrm{x}_{1}, u_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}, u_{n}\right\rangle\right) \xrightarrow{c}\langle P, i, u\rangle$ is in $\Delta_{*}$, then it is also in $\Delta_{0}$. Moreover, $\mathrm{x}_{i}=\mathrm{i}$ for all $1 \leq i \leq n$.

Proof: Such rules are introduced at Step 1 and hence the claim follows from the construction of $\Delta_{0}$.

Proposition 33 If the rule $f\left(\left\langle P_{1}, \mathbf{x}_{1}, u_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathbf{x}_{n}, u_{n}\right\rangle\right) \xrightarrow{c}\langle P, \mathbf{a}, u\rangle$ is in $\Delta_{*}$, then $i \in \mu(f)$ implies $\mathrm{x}_{i}=\mathrm{a}$.

Proof: From the construction of the transition rule.
Next we show several technical lemmas. These are necessary to prove completeness and soundness of $\mathrm{P}_{\text {csin }}$. We abbreviate the proofs of Lemma 35 and 39-40 since their proofs are similar to the case of $\mathrm{P}_{\mathrm{cs}}$.

If $f\left(\left\langle P_{1}, \mathrm{x}_{1}, u_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}, u_{n}\right\rangle\right) \xrightarrow{c}\langle P, \mathrm{x}, u\rangle \in \Delta_{k}$, then we have
$f\left(u_{1}, \ldots, u_{n}\right) \xrightarrow{c^{\prime}} u \in \Delta_{\mathrm{NF}}$ where $c$ is of the form $c=c^{\prime \prime} \wedge c^{\prime}$ for some $c^{\prime}$. Thus, if $t$ satisfies $c$ then $c^{\prime}$ is also satisfied. Since we have $\left.t\right|_{i} \xrightarrow[\Delta_{\mathrm{NF}}]{*} u_{i}$ from the induction hypothesis, we have $t \xrightarrow[\Delta_{\mathrm{NF}}]{*} f\left(u_{1}, \ldots, u_{n}\right) \xrightarrow[\Delta_{\mathrm{NF}}]{ } u$.

Lemma 35 Let $s, t \in \mathcal{T}(F), s \xrightarrow[\Delta_{0}]{*}\langle P, \mathrm{x}, u\rangle$, and $t \underset{\Delta_{0}}{*}\left\langle P^{\prime}, \mathrm{x}^{\prime}, u^{\prime}\right\rangle$. Then, $P=P^{\prime}$ iff $s=t$.

Proof: Similar to the proof of Lemma 9.
Lemma 36 Let $\alpha: t \xrightarrow[\Delta_{*}]{\stackrel{*}{\longrightarrow}} t[\langle P, \mathrm{a}, u\rangle]_{p} \xrightarrow[\Delta_{*}]{*}\left\langle P^{\prime}, \mathrm{a}, u^{\prime}\right\rangle$ and $p \in \operatorname{Pos}^{\mu}(s)$. Then $u^{\prime} \in Q_{\mathrm{NF}}^{f}$ implies $u \in Q_{\mathrm{NF}}^{f^{\Delta_{*}}}$.

Proof: We show this lemma by induction on $|\alpha|(>0)$.
(1) Consider the case where the last transition rule applied in $\alpha$ is (of the form) $f\left(\left\langle P_{1}, \mathrm{x}_{1}, u_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}, u_{n}\right\rangle\right) \xrightarrow{c}\left\langle P, \mathrm{a}, u^{\prime}\right\rangle \in \Delta_{*}$. In this case, the position $p$ can be represented as $i p^{\prime}$ for $1 \leq i \leq m$. From the construction of the transition rule $f\left(\left\langle P_{1}, \mathrm{x}_{1}, u_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}, u_{n}\right\rangle\right) \xrightarrow{c}\left\langle P, \mathrm{a}, u^{\prime}\right\rangle$, we have the transition rule $f\left(u_{1}, \ldots, u_{n}\right) \xrightarrow{c^{\prime}} u^{\prime} \in \Delta_{\mathrm{NF}}$ for $c^{\prime}$. Proofs of the following Lemmas 40-43 are similar to the ones of Lemma 1114, because we do not need to consider the third components of the states.

Lemma 41 If $\left\langle P_{1}, \mathrm{a}, u\right\rangle \xrightarrow[\Delta_{*}]{\stackrel{*}{*}}\langle P, \mathrm{a}, u\rangle$, then there exists $P_{1}^{\prime} \subseteq P_{1}$ such that $\left\langle P_{1}^{\prime}, \mathrm{a}, u\right\rangle \xrightarrow[\Delta_{*}]{*}\left\langle P^{\prime}, \mathrm{a}, u\right\rangle$ for all $P^{\prime} \subseteq P$.

Proof: Similar to of Lemma 13.
Lemma 42 If $t \xrightarrow[\Delta_{*}]{*}\left\langle P^{j}, \mathrm{a}, u\right\rangle$ for $1 \leq j \leq m$, then we have $t \xrightarrow[\Delta_{*}]{*}$ $\left\langle\bigcup_{1 \leq j \leq m} P^{j}, \mathrm{a}, u\right\rangle$.
$1 \leq j \leq m$
Proof: Since the proof of this lemma is similar to the proof of Lemma 12, we describe a concrete proof in Appendix A.2.1. The difference between proofs of this lemma and Lemma 12 is in the constraints. However, since the constraint of the transition rule produced at (1) of Step 3 of $\mathrm{P}_{\mathrm{csin}}$ is simple, the difference does not cause difficulty.

Lemma 43 If $t \underset{\Delta_{*}}{\stackrel{*}{\longrightarrow}}\langle P, \mathrm{a}, u\rangle$, then $t \underset{\Delta_{*}}{\stackrel{*}{\longrightarrow}}\left\langle P^{\prime}, \mathrm{a}, u\right\rangle$ for any $P^{\prime} \subseteq P$.
Proof: Since the proof of this lemma is similar to the proof of Lemma 14, we describe a concrete proof in Appendix A.2.2. The difference between proofs of this lemma and Lemma 14 is in the constraints. However, since the constraint of the transition rule produced at (1) of Step 3 of $\mathrm{P}_{\mathrm{csin}}$ is simple, the difference does not cause difficulty.

The following lemma is a key lemma to prove completeness of $\mathrm{P}_{\text {csin }}$.

Similarly to Lemma 15 , we show the proof in the case where $s \underset{\mathcal{R}}{\longrightarrow}$ in $t$, and from Lemmas 39, 42, and 43. This proof is sufficient to prove the transition $f\left(l_{1}, \ldots, l_{n}\right) \sigma \underset{\Delta_{*}}{*} f\left(\left\langle P_{1}, \mathrm{x}_{1}, u_{1}\right\rangle, \ldots,\left\langle P_{n}, \mathrm{x}_{n}, u_{n}\right\rangle\right) \underset{\Delta_{*}}{\longrightarrow}\langle\{q\}$, a, $u\rangle$ and the rewrite rule $f\left(l_{1}, \ldots, l_{n}\right) \rightarrow g\left(r_{1}, \ldots, r_{m}\right) \in R$, we have the transition $g\left(r_{1}, \ldots, r_{m}\right) \sigma \xrightarrow[\Delta_{*}]{*}$

Similarly to the proof of Lemma 15, we have the transition rules $g\left(\left\langle P_{1}^{\prime}, \mathrm{x}_{1}^{\prime}, u_{1}^{\prime}\right\rangle, \ldots,\left\langle P_{m}^{\prime}, \mathrm{x}_{m}^{\prime}, u_{m}^{\prime}\right\rangle\right) \xrightarrow{c^{\prime}}\left\langle\{q\}, \mathrm{a}, u^{\prime}\right\rangle$ (see (1) of Appendix A.3) and each component of states is determined as the definition of $\mathrm{P}_{\mathrm{csin}}$. Thus, $i=j$ is not satisfied by $f\left(l_{1}, \ldots, l_{n}\right) \sigma$, and hence, there is no problem replacing $i=j$ in $c$ by $\perp$ in $c_{2}$.

Next we show that $g\left(r_{1}, \ldots, r_{m}\right) \sigma$ satisfies $c_{1}$ and $c_{2}$ of $c^{\prime}$ defined as the definition of $\mathrm{P}_{\mathrm{csin}}$.

For $l_{i} \notin X^{*}, l_{i} \sigma=l_{i} \xrightarrow[\Delta_{k-1}]{*}\left\langle P_{i}, \mathrm{x}_{i}, u_{i}\right\rangle$ from Step 2
of $\mathrm{P}_{\mathrm{csin}}$. For $l_{i} \in X$ and there exists $h$ such that $l_{h}=l_{i}$ and $\mathrm{x}_{h}=\mathrm{i}$, since there is no term other than $l_{h} \sigma$ that transits to $\left\langle P_{h}, \mathrm{x}_{h}, u_{h}\right\rangle$ from Lemma 35, we have $l_{i} \sigma=l_{i} \sigma^{\prime}$ and hence $l_{i} \sigma \xrightarrow[\Delta_{k-1}]{*}\left\langle P_{i}, \mathbf{x}_{i}, u_{i}\right\rangle$. For $l_{i} \in X$ such that there is no $k$ such that $l_{h}=l_{i}$ and $\mathrm{x}_{h}=\mathrm{i}$, we have $l_{i} \sigma \xrightarrow[\Delta_{*}]{*}\left\langle P_{i}, \mathrm{x}_{i}, u_{i}\right\rangle$ from Lemma 42. - If $l_{i} \notin X$, we have $i=j$ in $c$ but we have $l_{i}=l_{j} \sigma$ from Lemma 34 and Proposition 26.
Moreover, we have $i=j$ or $i \neq j$ in $c$ for $i^{\prime}=j^{\prime}$ or $i^{\prime} \neq j^{\prime}$ in $c_{2}$. These kinds of constraints are satisfied by $f\left(l_{1}, \ldots, l_{n}\right) \sigma$ similarly to the statement in Lemma 44.
Since $u_{i} \in Q_{\mathrm{NF}}^{f}$ or $\mathrm{x}_{i}=\mathrm{i}$ for all $i, l_{i} \sigma$ is a normal form or $i \notin \mu(f)$ for each $i$ from Lemma 34 and the procedure. Hence we have $f\left(l_{1}, \ldots, l_{n}\right) \sigma \underset{\mathcal{R}}{ }$ in $g\left(r_{1}, \ldots, r_{m}\right) \sigma$. Here $\alpha \sqsupseteq \alpha^{\prime} \sqsupset \beta$ follows. Thus, we have $s \stackrel{*}{\mathcal{R}}_{\text {in }} f\left(l_{1}, \ldots, l_{n}\right) \sigma \underset{\mathcal{R}}{ }$ in $g\left(r_{1}, \ldots, r_{m}\right) \sigma \stackrel{*}{\mathcal{R}}$ in $g\left(t_{1}, \ldots, t_{m}\right)=t$ and $s \xrightarrow[\Delta_{0}]{*}\langle\{q\}, \mathrm{a}, u\rangle$ for some $u$ by the induction hypothesis.
If a CS-TRS has an erasing variable, we cannot prove Lemma 47 as the above proof. Assume that the transition rule $g\left(\left\langle P_{1}^{\prime}, \mathrm{x}_{1}^{\prime}, u_{1}^{\prime}\right\rangle, \ldots,\left\langle P_{m}^{\prime}, \mathrm{x}_{m}^{\prime}, u_{m}^{\prime}\right\rangle\right) \xrightarrow{c^{\prime}}$ $\left\langle\{q\}, \mathrm{a}, u^{\prime}\right\rangle \in \Delta_{k+1}$ is produced from $f\left(l_{1}, \ldots, l_{n}\right) \rightarrow g\left(r_{1}, \ldots, r_{m}\right) \in R$ and $f\left(\left\langle P_{1}, \mathrm{x}_{1}, u_{1}\right\rangle, \ldots,\left\langle P_{m}, \mathrm{x}_{m}, u_{m}\right\rangle\right) \xrightarrow{c}\langle\{q\}, \mathrm{a}, u\rangle \in \Delta_{k-1}$. If we have the equality

or the disequality between $i$ and $j$ such that $l_{i}, l_{j} \in X, l_{i}$ is the erasing variable, and there exists $j^{\prime}$ such that $l_{j}=r_{j^{\prime}}$, then the equality or the disequality is not preserved to the produced rule.

The following lemma shows soundness of $\mathrm{P}_{\mathrm{csin}}$.
Lemma 48 If $\mathcal{R}$ be shallow, then $\mathcal{L}\left(\mathcal{A}_{*}\right) \subseteq \underset{\mathcal{R}}{ }$ in $[\mathcal{L}(\mathcal{A})]$.
Proof: Let $t \underset{\Delta_{*}}{\stackrel{*}{\longrightarrow}}\left\langle P, \mathbf{x}, u^{\prime}\right\rangle \in Q_{*}^{f}$ then we have $s \stackrel{*}{\mathcal{R}}$ in $t$ and $s \xrightarrow[\Delta_{0}]{\stackrel{*}{\longrightarrow}}\langle\{q\}, \mathbf{x}, u\rangle \in Q_{*}^{f}$ for some $q \in \stackrel{\Delta^{*}}{ }$ from Lemma 47. Since $s \stackrel{*}{\Delta_{0}}\langle\{q\}$, i, $u\rangle$ from Proposition 30, we have $s \underset{\Delta}{*} q \in Q^{f}$ from Proposition 28 .
Finally we obtain the following theorems from Lemma 45 and 48.
Theorem 49 For any shallow CS-TRS $\mathcal{R}$, we can construct a TACBB recognizing the set of terms that is innermost reachable from a term. Thus, innermost reachability is decidable for shallow CS-TRSs.

However, in general, we cannot always construct a TACBB recognizing the innermost reachable set from a regular set of terms for a CS-TRS, while we can construct a TACBB in the case of the ordinary TRS ${ }^{6)}$.

Theorem 50 There exists a regular set $L$ and a shallow CS-TRS $\mathcal{R}$ such that $\underset{\mathcal{R}}{*}[L]$ cannot be recognized by any TACBB.

Proof: Let $\operatorname{ar}(a)=0, \operatorname{ar}(f)=\operatorname{ar}(h)=\operatorname{ar}(i)=1, \operatorname{ar}(g)=2, L=\{f(t) \mid$ $t \in \mathcal{T}(\{h, a\})\}, \mathcal{R}=(R, \mu)$ where $R=\{f(x) \rightarrow g(x, x), h(x) \rightarrow i(x)\}$, and $\mu(f)=\mu(h)=\mu(i)=\emptyset, \mu(g)=\{1,2\}$. Then, we have $\underset{\sim}{\stackrel{*}{\mathcal{R}}}[L] \cap \mathcal{T}(g, h, i, a)=$ $\left\{g\left(t_{1}, t_{2}\right)\left|t_{1}, t_{2} \in \mathcal{T}(\{h, i, a\}),\left|t_{1}\right|=\left|t_{2}\right|\right\}\right.$. Since $\underset{\mathcal{R}}{\stackrel{*}{\mathcal{R}}}[L] \cap \mathcal{T}(g, h, i, a)$ cannot be recognized by any TACBB, $\mathcal{T}(g, h, i, a)$ is regular, and TACBB is closed under intersection, there exists no TACBB that recognizes $\underset{\mathcal{R}}{\stackrel{*}{\mathcal{R}}}[L]$.

## 5. Conclusion

In this paper, we proved that both reachability for right-linear right-shallow CS-TRSs and innermost reachability for shallow CS-TRSs are decidable.
One of our future works is to construct a TA that recognizes the set of reachable
terms from a regular set for a right-linear right-shallow CS-TRS. We described this problem in Section 3, but that does not mean that it is impossible to construct a correct TA. Since we have not found a TA and right-linear right-shallow CS-TRSs of which reachable sets cannot be recognized by any TA, this problem is still open.
Another future work is to find other subclasses that reachability, innermost reachability, or reachability of other strategies is decidable for TRSs or CSTRSs. One of the candidates is reachability for right-linear finite pass overlapping CS-TRSs where it is known that reachability is decidable for ordinary TRSs in Ref. 17). However, the class is complex and hence we think this is not easy. Innermost reachability for right-linear right-shallow TRSs is also a candidate. In the case of this class, to recognize the set of normal forms, we need TA with equality or disequality constraints. This automata has more complex constraints than that of TACBB and sometimes more complex constraints than constraints nests. Therefore, we think that this problem is much more complex than the result of this paper. Moreover, outermost reachability is a candidate. Outermost reduction is a strategy that rewrites outermost redexes. Today, no class is known such that outermost reachability is decidable.

## Appendix

## A. 1 Examples for Section 4

## A.1.1 An Example of TACBB Accepting the Set of Contextsensitive Normal Forms

Let CS-TRS $\mathcal{R}=(R, \mu)$ be as $R=\{a \rightarrow b, a \rightarrow c, f(x, b) \rightarrow g(x, a), g(x, x) \rightarrow$ $h(x, x)\}$ and $\mu(f)=\emptyset, \mu(g)=\{1,2\}, \mu(h)=\{1,2\}$. We construct the TACBB $\mathcal{A}_{\mathrm{NF}}$ such that $\mathcal{L}\left(\mathcal{A}_{\mathrm{NF}}\right)=\mathrm{CS}-\mathrm{NF}_{\mathcal{R}}$ by the algorithm shown in Section 4.1.
First, we construct a deterministic $\operatorname{TACBB} \mathcal{A}_{a}, \mathcal{A}_{f(x, a)}$, and $\mathcal{A}_{g(x, x)}$ at the first step of the algorithm.
The set of final states of $\mathcal{A}_{a}$ is $Q_{a}^{f}=\left\{U^{\circ}\right\}$ and the set of transition rules is $\Delta_{a}=$ $\left\{a \xrightarrow{\top} U^{\circ}, b \xrightarrow{\top} U_{\perp}, c \xrightarrow{\top} U_{\perp}, f(U, U) \xrightarrow{\text { }} U_{\perp}, g\left(U_{\perp}, U_{\perp}\right) \xrightarrow{\text { T }} U_{\perp}, g\left(U_{1}, U_{2}\right) \xrightarrow{\text { }}\right.$ $\left.U^{\circ}, h\left(U_{\perp}, U_{\perp}\right) \xrightarrow{\top} U_{\perp}, h\left(U_{1}, U_{2}\right) \xrightarrow{\top} U^{\circ}\right\}$ where $U, U_{1}, U_{2} \in\left\{U_{\perp}, U^{\circ}\right\}$ and one of $U_{1}$ and $U_{2}$ is $U^{\circ}$.

However, since $\mathcal{A}_{\mathrm{NF}}$ originally obtained from the algorithm is huge, we show a minified one. If we minify TACBB obtained by the algorithm, Proposition 26 may not hold. Therefore, we should not minify the TACBB obtained by the algorithm. In the case of following TACBB, Proposition 26 holds.
